

NOTE 1 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Annual Expenditure Limitation Report (AELR) is presented as prescribed by the *Uniform Expenditure Reporting System* (UERS), as required by Arizona Revised Statutes §41-1279.07, and in accordance with the voter-approved alternative expenditure limitation adopted August 26, 2014, as authorized by the Arizona Constitution, Article IX, §20(9). The alternative expenditure limitation provides for the Town to allow the Mayor and Council to adopt an annual expenditure limitation each year, which for fiscal year 2016-17 equaled the budget of \$125,885,698. This budget was formally adopted on May 19, 2016.
