EXECUTIVE REPORT

Town of Oro Valley | November 2022

TO COUNCIL

I'd like to begin by expressing appreciation to Town Council for appointing me as Interim Town Manager as we conduct our recruitment process. It is truly an honor to serve our community in this capacity, and I look forward to working with the Town's leadership team, staff, residents, and Council as we continue moving the organization forward in the coming months. I've just been notified that Tucson Local Media has been in contact with staff about this appointment, and I believe they are planning to run an article in the November 9 Explorer.



With the Vistoso Trails Nature Preserve Master Plan process upon us, staff has developed a community survey to gather data on what kinds of programs, activities and amenities our residents would like to see at the Preserve. The survey will be conducted both online and in print and will be available through November 30. Staff is also rolling out a series of public notifications so that residents are aware of opportunities to provide input. Notifications include a press release, with a list of opportunities scheduled through November 18 and a link to the survey, a print ad in the Explorer, a series of social media posts and inclusion in the Parks and Recreation weekly e-blast to 14,000+ users, to name a few. More details can be found on page 8 of this report. Staff will remain nimble in the coming weeks, identifying additional opportunities to further engage the public in this process.



On October 28, I attended the National Night Out event which was an incredible success. Thank you to our event partners, and to Chief Riley and her team. This event has grown to become a festival of family friend activities and educational opportunities, and it gets better every year. If you weren't able to attend, I encourage you to join us next year.



On November 9, I will be working with our Executive Leadership Team, laying the groundwork for Town Council's next Strategic Plan Retreat, which will be scheduled sometime in the New Year. On the 9th, staff and I will be reviewing the status of our current Strategic Plan and General Plan, and we will be discussing Town operations.

Just a reminder that the Welcome Reception for our newly re-elected Mayor and Councilmembers Nicolson, Barrett and Jones-Ivey will be held November 16th at 5 p.m., followed by their official swearing-in ceremonies. Congratulations to each of you.

Lastly, I'd like to close out by recognizing all our veterans who have served this country. To honor our veterans, staff is running a print ad in next week's Explorer and will be posting a Veteran's Day message on social media to express our gratitude for their service. Additionally, Town offices will be closed Friday, November 11 in observance of Veterans Day.

CASES AND STATISTICS

Quarterly Statistics

Please see the attached statistics for the first quarter of for fiscal year 2022/23.

Case 1

During a traffic stop on October 19, an officer learned that the occupant had an active felony warrant out of the South Carolina, U.S. Marshals Office for selling heroin. He was also noted to have a history of violent tendencies and resisting officers. The suspect was taken into custody without incident and will be extradited by the U.S. Marshall's Office back to South Carolina.

Case 2

OVPD's Criminal Investigation Unit investigated a child molestation in 2019 involving a biological relative of a child. After extensive investigation and judicial proceedings, the jury found the individual guilty on two counts of Child Molestation with a presumptive minimum prison sentence of 21 years.

Chief Riley was a guest speaker at the University of Arizona where she taught a class on **ethical decision making**.

Chief Riley attended the **dedication of the DEA building** in Tucson in the name of DEA Agent Garbo who was killed in Tucson in the line of duty October 2, 2021.



Single Family Residential Activity

13 new Single Family Residential (SFR) Permits were issued during the month of October compared to 19 SFR permits issued in September. Year-to-date, 179 SFR permits have been issued since the beginning of the year compared to 323 issued during the same period in 2021.

Permitting Activity

233 total permits were issued during the month of October compared to 305 permits issued in September. Year-to-date, 2,277 total permits have been issued since the beginning of the year compared to 2,160 issued during the same period in 2021.

MEETING/OTHER NEWS

Town Council

Graduates of the **October 2022 Community Academy** were recognized by Town Council on November 2. This was the 25th Community Academy, and the first program delivered in-person and online. The online option increased attendance rates and resulted in the highest graduation rate over the past five years. Nearly 100% of the participants graduated this year with 27 of the 28 participants attending four or more classes.



The private property owner's requests regarding proposed changes at the **Oro Valley Marketplace** was continued by Town Council on November 2. The applicant's proposed changes include a mix of apartments, hotels, retail, and restaurant. Council will continue the discussion on November 10.



On November 16, a final plat for a **large-lot subdivision south and west of W. Tortolita Mountain Circle** will be on the Town Council's consent agenda. The development consists of seven 3.3 acre (or larger) custom home lots zoned R1-144.

Neighborhood Meetings

On October 20, a pre-submittal neighborhood meeting was held regarding a private property owner's request for a grading exception and site design to allow a **41-lot detached residential subdivision** on an R-6 zoned property, located on the northwest corner of El Conquistador and Oracle Road (see preliminary design to the right). Should the applicant move forward, the next step is to submit a formal application.



On October 24, a focus area neighborhood meeting was held for a proposed rezoning to Planned Area Development (PAD) for the [Oro Valley Church of the Nazarene](#), located at the northeast corner of the Calle Concordia and Calle Buena Vista intersection. The proposal is to allow new recreational facilities, including a sports field and multi-purpose building (see site plan to the right).

The purpose of the meeting was to facilitate a discussion between immediate neighbors and the church and encourage design solutions to lessen impacts to surrounding neighbors. The next step will be one of two required Planning and Zoning Commission public hearings.



NEW DEVELOPMENT

Oro Valley was included in state-wide searches by six prospective businesses in October. The Town was unable to respond to them for the following reasons:

- Project 1: The project needed heavy industrial zoning which is not available in Oro Valley.
- Project 2: The project needed heavy industrial zoning and 40-acres.
- Project 3: The project needed heavy industrial zoning and 90-100 acres.
- Project 4: The project needed rail service within 10 miles of the site.
- Project 5: The project needed a 100-acre site.
- Project 6: The project needed 700 acres with 300 acres adjacent and 100 acres outdoor storage.

PLANNING PROJECT HIGHLIGHTS

- On October 21, Town staff met with the Town’s consultants (Gensler) to kick-off the **Rooney Ranch Master Plan project**. The consultant will be leading several joint workshops to identify potential development scenarios for the Town-owned property located east of the Oracle Road and Pusch View Lane intersection. The scenarios will be presented to Town Council in January 2023.
- Per their representatives, **The La Posada at Pusch Ridge project** (formerly known as Nakoma Sky) has secured the necessary financing to move forward with the construction of Phase 1. This phase includes the 3, 4 and 5 story central independent living buildings, maintenance yard, pool area and trailhead. Phases 2 thru 5 include a community park, additional independent living homes, assisted living and memory care units, and future commercial. No timetable has been set for future phases. Additional information is available on OVprojects.com.
- On October 6, a pre-application meeting was held for the proposed expansion of **Extra Space Storage**, located southeast of the Oracle Road and Hardy Road intersection. The proposal is for a new 51,700 square-foot storage building and covered RV parking. If the applicant chooses to move forward, the next step will be a neighborhood meeting.

TOURISM

- Staff participated in the **Tucson Hispanic Chamber of Commerce Market Outlook Event**.
- Staff met with the Visit Tucson Director of Sales and Sports Sales Manager to review **upcoming trade show activities, and sales strategies**.
- Staff developed a **sports marketing brochure** for Visit Tucson trade shows including the October Annual TEAMS convention in Oklahoma.
- Staff developed a themed marketing brochure for **Visit Tucson Canada and Mexico Visitors** recruitment that includes information related to the traveler types prevalent in Oro Valley.
- Staff updated the **leading platform for meeting planners**, CVENT, with all the Town’s venues specs. This platform is used by 95% of the group meeting planners. Visit Tucson will also have our venue specs to use in their sales efforts.

PUBLIC WORKS

BOND PROJECTS

Note regarding the status of each project: Construction is fast moving, and conditions will have changed by the time you receive this report.

Naranja Park Expansion

Value engineering continues. Staff, the design team and the contractor are working together to provide the maximum number of amenities while looking at more cost-effective means to provide baseline infrastructure. In the end, the cost cutting measures still need to perform correctly as this is the very foundation of the park's functionality.

Mass grading is near competition, and construction between fields 1&2 and 3&4 continues.



La Cañada Multi-Use Path – Lambert Lane to Naranja Drive

The design phase is underway. The consultant (AECOM) anticipates completing the design and starting construction early next year, dependent on the bond value engineering efforts.

ENGINEERING/GENERAL PROJECT UPDATES

Pavement Preservation

Phase 1, which was HA5 seal, is complete. Phase 2, which involves fog sealing is underway. Phase 2 will consist of a liquid road application. Phase 4 will apply Gilsonite and remove and replace pavement sections. The final phase will involve applying mastic to various pavement sections around town.

Steam Pump Ranch

The contractor is working on windows, doors, cabinets and tile, and has finished electrical, fire, and finished trimming as of the last week in October. Tucson Electric Power has completed the electrical service lines into the project site. Project is tentatively scheduled to be completed by the first week in November.

Steam Pump Ranch Bunk House and BBQ

Project was advertised at the end of October. Construction is scheduled to start in January 2023.

Wildlife Fencing for SR77

The contractor is clearing areas for wildlife fence and masonry wall. Project completion date is scheduled for late November.

Naranja Drive Multi-Use Path Project

The Town was awarded federal funds for the project, and staff is currently working on the IGA for the RTA funds which will be used as part of the 5.7% matching funds.

Westward Look Drive

This project is currently out to bid.

Traffic Signals

- Staff fixed the damage done to the pole and box at the La Cañada/Moore roundabout.
- Staff found a large hornet's nest inside the camera housing at Rancho Vistoso Boulevard and Innovation Park Drive.



STORMWATER AND STREET OPERATIONS

Stormwater Utility Commission Field Trip

Stormwater Utility staff hosts an annual field trip for the commissioners to familiarize them with current floodplain conditions. This year's field trip was centered around the Gravel Pit Wash from its origins in the Tortolita Mountain foothills at the Vistoso Trails Nature Preserve to its terminus at the confluence with the Cañada Del Oro Wash. During the field trip, staff and commissioners engaged in discussions of current development, future planning efforts, project needs and the utilization of Open Space Floodplain Management.



Federal Emergency Management Agency/Insurance Services Office Annual Training

The Insurance Services Office (ISO) held their nationwide annual training in Tucson this year. ISO was formed as an advisory and rating organization for the property/casualty insurance industry to provide statistical and actuarial services, to develop insurance programs, and to assist insurance companies in meeting state regulatory requirements. The ISO is assisting FEMA in the development of statistical and claims analytics used for the Risk Rating 2.0 Flood Insurance program updates. Local jurisdictions were asked to participate in setting up a tour of areas related to floodplains and drainage infrastructure. Special attention was given to the Bighorn Fire and the associated efforts to mitigate post fire flooding. The Oro Valley Stormwater Utility was able to participate as a local host at the Oro Valley Marketplace to discuss the Cañada Del Oro Wash and Big Wash floodplains and the efforts that were made during the Bighorn Fire.



STREET OPERATIONS

- Post-monsoon sweeping has been completed in town limits north of Tangerine Road. Efforts to sweep the town limits south of Tangerine Road are currently in progress.
- Street crews have completed more than 40 sidewalk repairs town-wide since the beginning of fiscal year 2022/23.
- Street crews completed the bollard installation at the Oro Valley library.
- Arizona Department of Correction crews continue to battle the excessive overgrowth of vegetation due to an abundant 2022 monsoon season within all Town rights-of-way.
- Street crews are working on longer-term repairs on the La Cañada bridge.



TRANSIT

Annual Federal Report

Federal Transit Authority grant recipients (those receiving funding from the Urbanized Area Formula Program or Rural Formula Program), are required to submit data to the Federal National Transit Database in uniform categories. The Town of Oro Valley, doing business as Sun Shuttle Dial-a-Ride, successfully submitted their fiscal year 2022 report. These reports ensure the Town remains eligible for future funding.

Transit to Enhance Customer Service via TRIPSPARK Passenger Portal

A new user-friendly customer service web portal for the Sun Shuttle Dial-a-Ride is currently in the testing phase. Riders will have immediate access to their trip details, personal profiles and can know exactly when their vehicle will arrive. With advanced notification, staff will be able to avoid no-shows and late cancellations. Customers will be able to book online and control their payment accounts. This new web-based service is being tested now in partnership with the Innovation and Technology team and should be available soon.

PARKS & RECREATION

ADMINISTRATION

Vistoso Trails Nature Preserve

- Master Plan – The Sites Southwest consultant team project managers Liz Cole and George Radnovich will be in Oro Valley the week of November 14. Meetings with Councilmembers have been scheduled. Additionally, the team will conduct field research and host community meetings on the following dates:
 - Tuesday, November 15 - Parks and Recreation Advisory Board meeting
 - Wednesday, November 16 - Community Workshop at Oro Valley Library, and Town Council meeting
 - Thursday, November 17 - Community Meeting in Council Chambers

- Restrooms – Work on the three restroom buildings continues. The northernmost and southernmost buildings are scheduled to open on November 18. Work at the building off Vistoso Highlands will take longer due to coordination with TEP. As a reminder, each building will have one unisex restroom open as part of Phase I. Staff is currently in design of Phase II, which will result in one ADA-accessible unisex restroom per building.

Parks and Recreation Advisory Board

The November 15 meeting will be the last meeting for three members who have served on the Board for four years: Chair Anna Clark, Vice Chair Joseph Coil and Member Ron O'dell.

AQUATICS

November 6 marks the start of the **Winter Season** for the Oro Valley Aquatic Center (OVAC). The winter season runs through March 11.

On November 11 - 13, the Oro Valley Aquatic Center will host the **Cactus Classic Reginal Water Polo Tournament** presented by Old Pueblo Water Polo. This regional tournament will attract over 100 adult men and women from surrounding states.

OVAC is preparing for its **facility closure for December and January** to complete the capital improvement projects to the pump room approved in the Fiscal year 2022/23 budget. During this closure, a new filtration, circulation and plumbing system will be installed as well as an expansion of the pump room to create space for these new additions. Additional projects during this closure will include a full deep cleaning of the pool decking and facility landscaping, deep cleaning of tile and plaster in both the recreation and Olympic pools, and upgrades to the competition equipment which includes the dive stands and new diving boards. Communication to members, the public and media will be sent at the start of November via email and a press release. All memberships will be paused for the duration of the project. Updates on project status will be provided via the Parks and Recreation webpage on the Town website.

COMMUNITY AND RECREATION CENTER

The Community and Recreation Center (CRC) installed **new cardio equipment** (six ellipticals, six recumbents, two upright and one stair climber) on October 18. The CRC will be replacing the strength equipment at the facility and anticipate installation in January-February 2023.

The CRC will be **refurbishing its pool deck** and will close the pool November 14-27. This project will include cleaning, coating and sealing the pool deck to provide an improved and safer surface.



The CRC is excited to bring back the **Community Center field trip program** this fall with an excursion to the University of Arizona football game against Arizona State University on November 25. The event will include tickets near the 20-yard line and transportation to and from the game.

PARK MAINTENANCE

The Park Management team installed a **new irrigation system** in the front lawn of the Community and Recreation Center. The new system improves irrigation efficiency saving water and producing a better turf. Overseeding the lawn begins in November.



Logistics and set-up were provided for the **Rockin' 4 Heroes concert** at James D. Kriegh Park. Over 1,200 people attended the event.

Naranja Park fields 1 and 2 will be closed for overseeding through November 13.

RECREATION AND CULTURE

The Naranja Park Archery range is now the home range of the **University of Arizona Archery Club**. The club and its 60 members have started using the range three days a week for practice and archery activities.

The new **Oro Valley Hiking Series** that meets the first Saturday of November-April will begin on November 5 at Catalina State Park. The registration for the series sold out in a matter of weeks.

The Desert Destroyers JOAD archery club will be hosting its annual field shoot on the east and west archery walking ranges on November 19 and 20.

GOLF

Golf rounds for October show 5,621 total rounds at the 36-hole facility. The Pusch Ridge Course opened November 1 for daily and league play.

As of October 21, there are 331 Full Memberships with 8 Corporate Memberships. The **marketing focus for November** will be on full-time and corporate memberships. A TV ad will launch on the Golf Channel for the 36-hole course in addition to the current Pusch Ridge ad in November.

On Thanksgiving Day, there will be a **member Turkey Shoot** at 8:30 a.m. and open for non-member tee times between 7:30 a.m. and 12:00 p.m.

The Overlook will be offering a **Thanksgiving buffet** between 12 p.m. and 4 p.m.

November projects and maintenance activities include rye grass fertilization, pre-emergent weed application, bunker edging, wash maintenance, tree pruning, desert maintenance, greens fertilization and sprinkler edging.

WATER UTILITY

METER OPERATIONS

As of October 26, the Utility had a total of 21,210 service connections which includes 25 new water meters installed by meter operations staff in the month of October.

WATER OPERATIONS

The Utility's Water Operations group continues to keep the water system operational with a robust Operations and Maintenance program. Operators continuously repair and replace water infrastructure assets to ensure uninterrupted service to the Town's water customers. Pictured to the right: A water production operator replaces a 150 HP electric motor on a production well. The old motor will be reconditioned and added to the Utility's inventory for future service. This type of work is perpetual in nature and ensures our community's sustainability.

2022 1st thru 3rd Quarter Water Delivery Metrics by Water Type



The Utility continues to successfully deliver Central Arizona Project (CAP) water and reclaimed water to reduce our community's reliance on groundwater. The following graphs compare water deliveries to both the Oro Valley service area and Countryside service area by water type for the aggregate of the 1st, 2nd and 3rd quarters since 1999.

Water deliveries to the **Oro Valley service area** for the first three quarters of 2022 consisted of:

- 427 million gallons of reclaimed water
- 588 million gallons of CAP water
- 1.10 billion gallons of groundwater

Water deliveries to the **Countryside service area** for the first three quarters of 2022 consisted of:

- 43 million gallons of CAP water
- 113 million gallons of groundwater

INNOVATION AND TECHNOLOGY

Technology Updates

The Oro Valley Innovation and Technology (I&T) team completed Phase 1 of the Data Center Relocation Project to move the current data center in the Administration Building to the Police Department Main Building. This newer data center has been updated, features a robust UPS power backup, all designed with the Town’s growing IT needs in mind. I&T looks forward to a formal unveiling later in November.



OV Peak Performance

The OV Peak Performance program launched a new Green Belt Workshop with 14 Town employees on October 18. This workshop will train the participants in Lean Six Sigma methodology, and upon completion all participants will be certified GoLeanSixSigma Green Belts.

Lean Six Sigma is a process improvement methodology that relies on a collaborative team-oriented approach to improve performance by systematically eliminating problems, removing waste and inefficiency, improving working conditions, and reducing variation in order to provide a better response to customer’s needs, improved organizational operations, and a framework for overall organizational culture change.

Emergency Management and Safety

Town Emergency Management coordinated a test of the Town’s “Lockdown” communication system on October 26. In combination with other physical security features in Town premises, this phone feature may be utilized to quickly broadcast important notifications or provide emergency alerts to staff located in Town facilities. Over 80 staff responded to the lockdown survey, with 77% having successfully heard the broadcast. Next steps include integration with Town fire drills, and shelter-in-place plans.


Oro Valley Youth Advisory Council (YAC)
