Thank you for participating in the Travel Reduction Program (TRP) Employee Survey. Pima Association of Governments (PAG) appreciates your cooperation in this process. This data will be used to calculate TRP emission benefits and alternative mode usage, which is reported to the Arizona Department of Environmental Quality. It will also be used to plan new transit routes and schedules and evaluate new infrastructure projects. Your next survey date is September 2020.

Town of Oro Valley earned a Bronze Award in the TRP Recognition Program by exceeding the Travel Reduction Ordinance goal of 40%. Your organization will be listed in the next Sun Rideshare Newsletter, the Sun Rideshare web site, and shared through social media.

The results of the employee survey are provided in the attached report. Alternative mode usage is based on one-way trips as recorded by each respondent. Your employees will 133,328 miles and 1,750 pounds of pollution in 2019 by using alternative transportation. Also included is a "heat" map of where your employees live. This map shows where there is enough density to form carpools and vanpools.

PAG staff can also advise your organization of ways to promote alternative transportation at the work place and help your employees find reliable, affordable and convenient transportation options. On behalf of the TRP Regional Task Force, PAG staff and the region, thank you for your continued support and implementation of the TRP.



