## **Oro Valley Historic Preservation Commission Highlights, Decisions Made, Special Projects from September 2013 through June 2014**

### **September 9, 2013**

- A summer historic archeology camp will be held at Steam Pump Ranch.
- The Farmer's Market will move to Steam Pump Ranch beginning the first week of October.

### **(no October meeting)**

### **November 4, 2013**

- The definition and role of the Historic Preservation Commission was reviewed by Tobin Sidles, Director of Legal Services, Town of Oro Valley. Discussion followed.

### **December 2, 2013**

- Ellen Guyer was re-appointed as Commission Chair. Dean Strandskov was re-appointed as Commission Vice-Chair. (Motion made, seconded and carried 6-0).
- The Commission voted to endorse the "Hands- On Archeology" between the Town of Oro Valley and Archeology Southwest.
- The direction for the annual Historic Preservation Commission work plan was set and grouped into five categories by Chair Guyer.

### **January 6, 2014**

- The Oro Valley Cultural Heritage Plan was reviewed and discussed by the Commission. Commissioners volunteered to re-write sections of the plan, to be reviewed at the March 2014 Commission meeting.

### **February 6, 2014**

- Commissioners Lane and Trail presented a report on Historic Preservation Commission Public Outreach, including the following points;
- public relations
- public knowledge of the Historic Preservation Commission and its' role in the community
- the importance of written materials

-funding

-4<sup>th</sup> grade curriculum

-the role of the Historic Preservation Commission as it differs from the Oro Valley Historical Society

---

A Commission sub-committee will work with the Oro Valley Historical Society to write and design a brochure, focusing on Oro Valley's heritage, cultural and historical sites.

### **March 3, 2014**

-Chair Guyer will provide a letter of support for the Pima County Bond, on behalf of the Historic Preservation Commission.

-Revisions to the Oro Valley Cultural Heritage Preservation Plan were reviewed. The updated document will be reviewed in total by the Commission at the April meeting.

### **April 7, 2014**

-Chair Guyer was appointed as the Historic Preservation Commission's formal representative to Oro Valley's "Your Voice/Our Future" project, an update to Oro Valley's General Plan with community input.

-The final draft of the Oro Valley Cultural Heritage Preservation Plan was approved and accepted by the Commission.

-Commissioner Trail was appointed as the Historic Preservation Commission's liaison to the Parks and Recreation Advisory Board.

-Chair Guyer will contact the Oro Valley Historical Society Chair and schedule a joint study session with the Historic Preservation Commission.

- Commissioners will attend the Town's 40<sup>th</sup> Anniversary celebration on April 26<sup>th</sup>, provide brochures and recruit additional Commission applicants.

### **May 5, 2014**

-A tour of historic homes and neighborhoods will be conducted for interested Commission members in the fall.

-Parks and Recreation Director Ms. Diaz-Trahan will provide the accepted version of the Oro Valley Cultural Heritage Preservation Plan to the Town council for adoption.

-The Commission established a sub-committee to prepare an annual report for Certified Local Governments, to be submitted to the State Historic Preservation Office, and provided to the public. This sub-committee will also review Certified Local Government requirements for compliance, benefits to Oro Valley and the Historic Preservation Commission, and recommend a work plan for the 2014-2015 Historic Preservation Commission.

-The joint meeting of the Historic Preservation Commission and the Oro Valley Historical Society will be held in November, 2014.

### **June 2, 2014**

-Per the Town budget, \$125,000 was received in capital for the preservation of the pump house at Steam Pump Ranch.

-\$43,000 was received in operations and maintenance for Steam Pump Ranch.

-A tour of Honeybee Village, conducted by archeologist Henry Wallace, will be held on October 12, 2014 for the benefit of Historic Preservation Commissioners.

-A motion was made and seconded to request funds for the Certified Local Government program specifically earmarked to the assessment and prioritization of the contributing structures at Steam Pump Ranch. The motion carried, 5-0

**3. DIRECTOR'S REPORT**



Ms. Diaz-Trahan reported on the items below.

Events/Programs include:

- This summer, there was a historical archeology camp at Steam Pump Ranch.
- Farmer's Market will move to Steam Pump Ranch beginning the first week of October.
- Fall Festival is October 26, 2013.
- Second Saturday events.

Projects include:

- A construction shade structure is in progress at Steam Pump Ranch.
- The Tack House is being secured and the Oro Valley Historic Society will store donated items in the building.
- The Bond Advisory Committee has had no action since the last meeting. No changes have been made to the department's \$4 million request.

#### **4. ROLE OF THE HISTORIC PRESERVATION COMMISSION - DISCUSSION & POSSIBLE ACTION**

Ms. Diaz-Trahan reviewed the two documents which were handed out:

- Section 21.9 outlines the powers and duties of the Historic Preservation Commission as part of the general plan.
- Article 6-10 is the Historic Preservation Code. This is the guiding document for this commission, historic designation, planning and zoning, construction, etc.

Ms. Diaz-Trahan explained that this item is being reviewed because she attended the Historic Preservation Conference this year and attended a workshop which reviewed the roles of a historic preservation commission and she came to the conclusion that some actions and agenda items may not fit the roles. She referred to Article 6-10, Section 6-10-5 under Section F (Powers and Duties). The majority of the duties deal with design guidelines.

Ms. Diaz-Trahan recommended inviting the Town Attorney to attend the meeting in October to clarify from a legal standpoint. She stated that the handouts may be reviewed by the commission members in preparation for the next meeting.

Commissioner Hannon pointed out that when the commission was first established, it was part of the Planning and Zoning Department and the document has that role in mind, but since the commission was transferred to Parks and Recreation, it has gone a different direction.

**2. ROLE OF THE HISTORIC PRESERVATION COMMISSION  
PRESENTED BY TOBIN SIDLES, DIRECTOR - LEGAL SERVICES -  
DISCUSSION**

Director of Legal Services Tobin Sidles discussed the difference between State Parks board duties versus the Oro Valley Historic Preservation Commission (HPC). He reviewed all 24 powers and duties of the HPC, as outlined under the Town Code, Section 6-10-5.

Mr. Sidles explained that the HPC is a resource for the Parks and Recreation Advisory Board (PRAB) and the Parks and Recreation Director. The Director may take recommendations made by the Commission to the Town Council.

Parks and Recreation Director Kristy Diaz-Trahan stated that the Commission started out as a Planning and Zoning function and when the documents were written, the intent was to reflect that placement. The HPC duties reference working collaboratively with PRAB. The transition to the Parks and Recreation Department has caused the need to have Mr. Sidles review how the communication flow should work.

### **3. ARIZONA ARCHAEOLOGY & HERITAGE AWARENESS MONTH EXPO UPDATE - DISCUSSION**

Recreation Manager Lynanne Dellerman explained that the Expo will include a Steam Pump Ranch pit house demonstration, garden and ranch tours. The event will be at Catalina State Park on Saturday, March 29th. There will be a table for the Commission, staff and any of the historically significant groups in the Town.

### **4. DIRECTOR'S REPORT (DISCUSSION MUST BE LIMITED TO INFORMATION AND CLARIFICATION)**

Ms. Diaz-Trahan reported on the following:

- The Farmer's Market has been a success at Steam Pump Ranch.
- The Fall Festival was a huge success and well attended.
- Second Saturdays are planned out for the next six to eight months. Through a partnership with Archaeology Southwest, they have built a pit house replica.
- The Pima County Bond Advisory Committee has postponed the project for at least one year. Steam Pump Ranch improvements and implication of the Master Plan is still a tentatively approved project. Starting in February, the Bond Committee will be reviewing projects in clusters by topic (historic cluster, parks and recreation cluster, revitalization, etc.). Ms. Diaz-Trahan will present on behalf of the Town for historic items and support work at Honey Bee Preserve on behalf of Pima County and trail work from Steam Pump Ranch under Oracle Road into Catalina State Park.
- Archaeology Southwest has provided a proposal for partnership work and they would like to present next month to this Commission.

### **4. PRESENTATION BY WILLIAM H. DOELLE, PRESIDENT AND CEO OF ARCHAEOLOGY SOUTHWEST - DISCUSSION AND POSSIBLE ACTION**

President of Archaeology Southwest William Doelle distributed copies of Archaeology Southwest Magazine and the "Hands-On Project" Guiding Principles. He reviewed the materials, discussed his organization's focus and proposed the following:

- ~ A partnership with the Town of Oro Valley to link Honey Bee Village, Catalina State Park and Steam Pump Ranch.
- ~ A "Hands-On Archaeology" program to add another pit house reconstruction at Steam Pump Ranch.

**MOTION:** A motion was made by Commissioner Thomae and seconded by Vice-Chair Strandskov to endorse the "Hands-On Archaeology" program partnership between the Town of Oro Valley and Archaeology Southwest.

**MOTION** carried, 6-0

### **5. SETTING THE DIRECTION FOR THE ANNUAL WORK PLAN - DISCUSSION AND POSSIBLE ACTION**

Chair Guyer reviewed the Historic Preservation Commission Powers and Duties (Article 6-10-5 Historic Preservation Code) and grouped them into the following five categories:

- 1) Historic Preservation Plan and maintaining the Historic Property Register (Items 1 and 8): A plan was presented in April 2011 to the commission. It was titled "The Oro Valley Cultural Heritage Preservation Plan: Developing and Sustaining a Community

Sense of Place". This document is a draft and was never endorsed. It will be reviewed and edited at a future Historic Preservation Commission meeting.

2) Management of Landmarks & Historic Districts (Items 2-7 and 17-18): This should include finding people who want their homes designated as historic. The commission concluded that a form letter, PowerPoint and speaking points need to be established. Chair Guyer recommended holding a special subcommittee meeting to discuss this item and to create the necessary documents.

3) Funding to Promote Historic Preservation (Items 11-14): Ms. Diaz-Trahan stated that fundraising is not a mission of the Commission, but is a value of the Oro Valley Historical Society.

4) Public Outreach (Items 15-16 and 9-10): There is need to increase public awareness by developing and participating in educational programs. The commission asked Ms. Diaz-Trahan to request budget funds for a general brochure to inform the public of Oro Valley's history. Another brochure should be created specific to Steam Pump Ranch.

Chair Guyer stated that placement for plaques and monuments within the historic core is not listed in the Powers and Duties, but should be addressed. She added that "budget needs" should be on future agendas. Commissioner Thomae recommended a budget request of \$25,000 this year.

5) General Duties (Items 19, 22-24).

The commission determined the following schedule relating to future Historic Preservation Commission agendas:

- ~ The Oro Valley Cultural Heritage Preservation Plan will be on the January agenda and it may be revisited in March.
- ~ Educational outreach proposals regarding historic preservation and Steam Pump Ranch will be on the February agenda.
- ~ Pump House restoration will be on the March agenda.
- ~ Recreation Manager Lynanne Dellerman will seek an educational guest speaker for the April meeting.

## **6. CLARIFICATION ON BOND PROJECT RELATING TO MASTER PLAN FUNDING - DISCUSSION**

Ms. Diaz-Trahan distributed copies of the department's submittal for "Steam Pump Ranch Master Plan Implementation". She provided information about the Bond Advisory Committee process and the Town of Oro Valley's request for \$4 million to implement the Master Plan. She added that the Pima County Bond Advisory Committee will discuss

historic preservation on March 21, 2014.

## **7. UPDATE ON RESTORATION OF THE STEAM PUMP - DISCUSSION AND POSSIBLE ACTION**

Ms. Diaz-Trahan and Ms. Dellerman met with Pump Engineer Ernie Shull and discovered that the steam pump is not at the ranch, but at the Arizona State Museum. Mr. Shull may assist in creating a wooden replica for educational purposes.

The following individual discussed the need for the Town of Oro Valley to fund Steam Pump Ranch restoration:

Oro Valley Resident Bill Adler

Ms. Diaz-Trahan invited commissioners to meet with her and Compusult at Steam Pump Ranch regarding price updates in order to prioritize the budget request. Commissioner Hannon, Chair Guyer and Commissioner Thomae volunteered to attend. Commissioner Lane offered to be a backup.

**2. ORO VALLEY CULTURAL HERITAGE PRESERVATION PLAN -  
DISCUSSION AND POSSIBLE ACTION**

Chair Guyer explained that the purpose of reviewing this document is to determine if it can be useful and if it should be adopted as is or revised. The commission discussed

the layout, purpose and scope of the document. The commission reviewed each section for editing and clarification, including the following:

- Section 1: "The Legal Context For Historic Preservation"
- Section 2: "Current Status of Oro Valley Cultural Resources and Tools For Their Management"
- Section 3: "A Context for Moving Forward"
  - Part 1: *Public Participation and Heritage Education* - Commissioner Thomae volunteered to rewrite Section 3, Part 1.
  - Part 2: *Historic Steam Pump Ranch*
    - Commissioner Thomae explained that the map from the Steam Pump Master Plan needs to be redone to be sure we conform to the National Register nomination.
    - A subcommittee from the Historic Preservation Commission should meet with the Oro Valley Historical Society to discuss relevant items.
    - Part 2 will be revised by Chair Guyer.
  - Part 3: *Historic Neighborhoods*
    - The Commission discussed the importance of having information to hand out to the public regarding nominating homes as historic places. Ms. Diaz-Trahan explained that there is a Historic Preservation Code and a process for such nominations, but there is no brochure/form.
    - Commissioner Hannon suggested this commission identify what properties we are interested in and reaching out to the homeowners.

### Question 1

In May 2008 I retired after 32 years of employment at Macalester College in St. Paul, Minnesota and moved permanently to Oro Valley. I spent the first year here adjusting to retirement and getting to know our new environment. Then this past summer I felt ready to seek opportunities to contribute to the well being of the community. I discovered the Citizen Planning Institute, which I have been a member of this fall, and am now excited about the possibility of joining a commission or board.

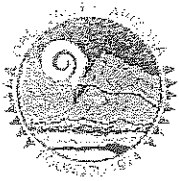
Since I have only recently retired and moved to Oro Valley, I do not have a record of local involvement. However, I have always had a strong belief in the value of civic engagement. Indeed, after I graduated from college I served as a volunteer in the Peace Corps and followed that with numerous volunteer positions in Minnesota. For example, one that meant a great deal to me was being a leader for a Girl Scout troop. My entire career was spent in higher education, a career that by its very nature involves a strong service ethic.

### Question 2:

I began at Macalester College, a four-year, private, liberal arts college, as a faculty member in the Department of Linguistics and English as a Second Language. In 1986 I took a position in the academic administration and became Dean of Academic Programs. My experiences in this position would enable me to be an effective committee member for the town of Oro Valley. I was a member and sometimes chair of numerous campus committees that involved working with multiple constituents: students, faculty, staff, administration and trustees. For example, I chaired the Reunion/Commencement Committee for several years. This committee planned the week-long event at the end of the year that enabled alumni to reconnect with the campus, parents to watch their children graduate, and trustees to conduct their business meeting and participate in events. Balancing the needs of these various groups required me to demonstrate skillful communication and careful attention to detail. Also, I co-chaired a committee called the Self-Study Committee, a group comprised of students, faculty, staff and trustees. This group was charged with conducting an examination of the current state of the College and then developing strategic plans for the future. There were many competing demands and interests, and thus I was required to manage our work with diplomacy and tact.

I could provide numerous other examples of work that engaged me over the years, all of which I offer as a means of demonstrating that I know how to be an effective committee member, to balance the needs of different groups in problem-solving and decision making and to adhere to the requirements set out by law or other regulations while negotiating the sometimes conflicting desires of different constituents.

I am particularly interested in the work of the Planning and Zoning Commission as it seems to require effective listening skills as well as an ability to weigh various sides of a problem and reach a conclusion accepted by all involved parties. Questions of changes to the zoning code or planning for future development will naturally require an ability to see the big picture, to meet the needs of diverse groups while following the requirements set out in the zoning code and general plan. I am particularly interested, for example, in how the town of Oro Valley proceeds with the expansion into Arroyo Grande insofar as it affects the quality of life in Oro Valley while protecting the natural environment. We live in an exciting time when the nature of Oro Valley seems to be changing, and I would welcome the opportunity to contribute to the future development of our community.
