### INTRODUCTION

The Oro Valley Historic Preservation Commission (HPC or the Commission) is charged with providing the historic perspective and review for the Town of Oro Valley, Arizona (Town). Through its monthly meetings, the HPC provides input and direction for the Town on issues involving historically significant resources. The Commission functions to ensure the preservation of historic buildings, districts, landmarks, structures, documents, photographs, and other artifacts that represent the historic background and development of the Oro Valley area. Further, the Commission actively promotes educational opportunities relating to the Town's history and preservation efforts. Since May 2009, the Town has maintained Certified Local Government (CLG) status under the National Historic Preservation Act of 1966. Pursuant to the CLG Historic Preservation Program in Arizona, Section III(C), this report details the activities of the HPC for the reporting period ranging from July 2016 through June 2017. This report includes highlight and special projects (and any cases reviewed), decisions made, meeting minutes, resumes of commission members, and commissioner attendance at meetings.

## I. Activity Highlights and Special Projects

The highlights of special projects and activities of the HPC are provided below for reference. This section also includes any HPC-reviewed cases and/or issues during this reporting period.

## A. Public Participation in Preservation Efforts and Heritage Education

In furthering these Commission goals, the HPC continues to distribute the Town's Cultural and Historic Resources brochure. The brochure includes information on the Town's history—from prehistoric Hohokam villages near the Tortolita and Santa Catalina Mountain ranges to nineteenth-century homesteads and ranches to twentieth-century suburban neighborhoods. This brochure discusses major Native American archeological sites in the Town, nineteenth-century ranching families, the Pusch family and the Steam Pump Ranch, and post-World War II development in the Town. The brochure also provides references for the public to access more information from the Town, the HPC, and the Oro Valley Historical Society.

Additionally, the HPC again sponsored the William Adler Historical Expository Writing Contest for local fourth-grade students in the Amphitheater Public School District (Amphi) and area home-school programs. The Commission worked to align the essay topics of the Contest with the Social Studies curriculum adopted by Amphi. This year, the HPC enhanced the Contest by engaging staff at Catalina State Park so that Contest entrants could have a complimentary interpretive tour of a Hohokam ruin. The HPC also collaborated with the Oro Valley Public Library so that Contest entrants could utilize its services for essay research. In May 2017, the HPC announced the winners of the Contest and they included: First Place winner Zach Phillips, Second Place winner Gavin Phillips, and Third Place winner Maya Lamoreaux. Winning entries remain available for public view on the Town website.

Finally, this year the Town hosted the 15th Annual Arizona Historic Preservation Conference. One morning during the conference, the Town hosted a breakfast at Steam Pump Ranch that included docent-led tours by the Historical Society and educational information regarding Honey Bee Preserve.

Other efforts of the HPC's William Adler Educational Outreach Program include work with the Oro Valley Historical Society on the Speakers' Bureau—a program aimed at educating the public on local history.

## B. Steam Pump Ranch

A continued focus of the Commission has been the Town's unique and valuable property—the Steam Pump Ranch. The HPC remains concerned with the deterioration of the historic-core buildings and structures on the property. These structures include the Pump House, Pusch Ranch House, Procter-Leiber House, Bunk Houses, Garage/Workers' Housing, Carlos' House/Former Barbecue Pavilion, Chicken Coop Structures, and the Stables. The Commission has worked to improve its ability to monitor the process of preservation and restoration at Steam Pump Ranch.

This year, the HPC ensured that stabilization work was completed as planned for the Chicken Coop Structures at Steam Pump Ranch. The Structures were at significant risk of complete loss prior to commencement of stabilization work. The Town also secured a grant to educate the public on adobe repair and conservation. With the help of the public, adobe repair work was completed at Steam Pump Ranch as well.

## C. Historic Neighborhoods

One of the HPC's primary concerns during this reporting period has been the development of a program for historic designation and recognition of private residences and neighborhoods in the Town. In previous years, the HPC has surveyed potentially significant properties throughout the Town.

This year, the HPC dedicated considerable attention to the identification of the Oro Valley Country Club Estates (OVCC) as a significant historic neighborhood. Commissioners have worked with residents of OVCC in order to advance the work of attaining historic designated status for the neighborhood. Specifically, Chair Thomae and Vice Chair Ohlson have had considerable contact with OVCC regarding the issue.

## D. Town History and Records

Although many of the Town's historic records and photographs remain available for public viewing at the Oro Valley Public Library, and the Oro Valley Historical Society maintains historic photographs and documents, the HPC continues to work toward its mission goal of creating and maintaining an inventory of significant artifacts. The HPC is encouraged by the support of such endeavors from both the Library and the Historical Society.

## E. Honey Bee Village

A focus of the work of the HPC remains Honey Bee Village. The Commission continues to explore the feasibility of public tours on the site in the future.

## F. 2017 Historical Writing Contest Winners

The Commission once again conducted a writing contest for elementary school students focused on topics of local historical significance. This year, the winners included: First Place: "The Time of the Hohokam" by Zach Phillips; "Hohokam vs. Modern" by Gavin Phillips; and "The Gadsden Purchase" by Maya Lamoreaux.

Chair Sunshine explained that the sign design was the second sample provided by the designer based on the Commissions direction. Further discussion included signage placement, cost, size range and uses. Consistency and uniformity was the agreed upon goal.

Chair Sunshine provided the background of the contest. Chair Sunshine explained that she and Commissioner Kane revised the essay rules to ensure fairness, they

changed the judging criteria to include independent thinking, and they reduced the point scoring structure for ease of grading. The Commissioners discussed amending Question 1 due to sophistication of wording. Ms. Diaz-Trahan recommended staff clean up and edit the document before submitting it to the teacher. Chair Sunshine welcomed anyone to express their interested in writing questions for future essays.

Previously, I served for many years as the chairwoman for the Tribal/ Federal Effective Sex Offender Management Task Force, a group of tribal and federal professionals volunteering to educate the community, identify and promote safety strategies, and manage identified sex offenders through community-based efforts with Native Americans in Southern Arizona.

I am not an expert in historical preservation by any means but I have an interest in the area and am actively addressing repair/restoration of historic structures at Valley of the Moon. One member provided an interesting report on options for protective coverings, with discussion of application to the Steam Pump Building. The Commission was navigating the language and intent of earmarked money, as well as educating each other on preservation goals and priorities. It was clear this group operates with civility and intention to do the right thing. I could see myself helping with these sorts of projects and discussion.

#### Briefly describe your educational/vocational background

I received a BA from Rutgers University with departmental distinctions in psychology. I was honored as a Paul Robeson Scholar for research of humanistic merit for two years. I completed clinical doctorate requirements clinical psychology at the University of Arizona, except for the minor and the dissertation but did not attain a PhD. I have completed a Masters level certificate program in business management through the federal government remote learning program. I have attended the Arizona Historic Preservation Conference the past two years but do not have formal training in preservation.

I have worked as an undergraduate research assistant, a graduate teaching assistant and a counselor for incarcerated juveniles, prior to service with U.S. District Court. With federal court, I started as a probation officer, was promoted to specialist (handling drug, mental health and then sex offenders), and completed my career as a supervisor. I have managed the sex offender unit, tribal lands, and Nogales. I retired five years ago. I currently own and manage a very small rental business, WhiteWave LLC. I also have a consulting business, The Consortium to Prevent Sexual Violence, which is largely inactive, although I do occasionally serve as a grant reviewer and community educator.

# VI. Commissioner Continuing Education and Training

The HPC continued to invite and support speakers at HPC meetings. Additionally, Oro Valley was the site of the 15<sup>th</sup> Annual Arizona Historic Preservation Conference. Commissioners were involved in various aspects of the Conference, including Chair Thomae discussing the HPC's efforts at designating the Oro Valley Country Club Estates as a historically significant neighborhood. The Town also supported a guided tour of the Steam Pump Ranch for Conference attendees.

#### CONCLUSION

The HPC celebrated another successful year. Preservation efforts continued at Steam Pump Ranch, and the HPC progressed in its commitment to develop an oral history project for the Town, collaborate with the Historical Society, grow the Historical Writing Contest for youth, and develop a landmark designation program for adoption by the Town.

The HPC also lost one of its commissioners when with Marilyn Lane's passing in September 2016. Commissioner Lane's contributions to the HPC were many and her service and friendship are tremendously missed.

Budgetary concerns also continue for the HPC. The Commission is focused on its efforts to support preservation work at Steam Pump Ranch—some of which has been stalled due to budget constraints.

The HPC looks forward to another year of working to protect and preserve the culturally significant resources that are unique and treasured by the citizens and staff of Oro Valley.
