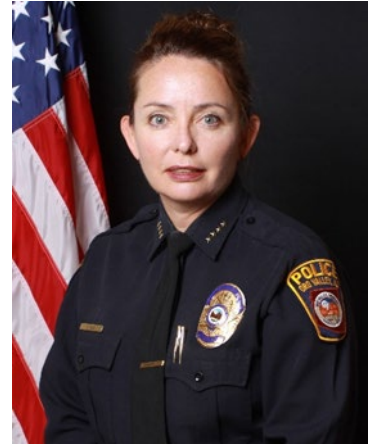

Focus Areas

The Oro Valley Police Department's Strategic Plan outlines the goals and strategies for the department to successfully address its mission. Our goal is to compliment the Town of Oro Valley's Strategic Leadership Plan to ensure a unified approach in providing the best services to the community. The four focus areas indicate where OVPD must direct its attention to address community needs are as follows:

- Promote Community Safety Through Visibility and Collaboration
- Community Trust and Transparency
- Strategic Staffing
- Facilities and Equipment Readiness

Within each focus area, there are goals and strategies that are action-oriented to convey desired outcomes.

- Focus areas are strategic initiatives that will be addressed.
- Goals describe a fundamental direction or broad course of action.
- Strategies are specific tasks to be accomplished when implementing the goal.

Focus Area: Promote Community Safety Through Visibility and Collaboration

Maintain a visible and proactive law enforcement presence in neighborhoods, schools, and on streets, with an emphasis on community policing, crime prevention programs, response times, and collaboration with the town court and prosecutor's office.

Goal: Enhance Community Presence

Strategies:

- Direct specific patrol initiatives based on crime trends and community input, and data.
- Continue to conduct routine, non-enforcement patrols and community engagement activities within these zones.
- Equip officers with the ability to log interactions and community contacts for reporting purposes.
- Partner with local businesses or community centers for co-hosted public safety days with programs such as Drug Awareness Day, National Night Out, Dispose-A-Med, Shred-A-Thon, and more.
- Explore technology which streamlines data analysis to bolster investigative and analytical capabilities.

Goal: Improve Cross Departmental Collaboration

Strategies:

- Re-establish monthly liaisons with the Town Court and the prosecutor's office.
- Implement warrant and case workflow improvements, re-vamp, and reinstitute a warrant service program.
- Collaborate with town partners to facilitate compliance with state fingerprinting and disposition requirements

Focus Area: Community Trust and Transparency

The primary focus of the Oro Valley Police Department is public safety. To accomplish this, we must foster meaningful relationships between law enforcement and the community by prioritizing transparency, collaboration, and proactive engagement to ensure all residents feel safe, heard, and respected.

Goal: Strengthen Community Trust and Engagement

Strategies:

- Continue and expand community events to maintain an open dialogue with residents.
- Video series stories highlighting individual officers, their motivations, and positive interactions with the public. Analyze current social media use and trends to ensure optimal community engagement
- Interactive Q and A's, such as You Ask, We Answer campaigns, responding to submitted questions about police policy or law.
- Explore officer feedback program platforms.
- Maintain agency accreditation through the Arizona Law Enforcement Accreditation Program.

Goal: Enhance Transparency

Strategies:

- Implement a public facing dashboard that includes crime data through an interactive map which allows residents to access crime information in their communities.

Goal: Encourage Community Collaboration

Strategies:

- Continue to foster and expand relationships with businesses through the Adopt-A-Business program.
- Continue collaboration with Neighborhood Watch groups and apartment communities through our Community Resources Unit.
- Continue community engagement through public outreach programs such as:
 - Citizens Academy
 - Neighborhood Watch groups
 - Coffee-with-a-Cop events
 - Teen Academy
 - Rape Aggression Defense (RAD) classes
 - Start Your Engines Ladies classes
 - Dispose-a-Med
 - Shred-a-Thon
 - National Night Out
 - OV Safe Return
 - 911 Kids Education
 - Crime Prevention Through Environmental Design

Focus Area: Strategic Staffing

Implement staffing strategies that align with community needs to ensure efficient operations, resource optimization, and high-quality public safety services.

Goal: Ensure Staffing Meets Community Demand

Strategies:

- Conduct periodic patrol workload assessments through existing police patrol operations management software.
- Annually evaluate current patrol deployment strategies.
- Ensure staff training remains relevant and timely to address community needs and crime trends.
- Align staffing forecasts with anticipated population increases, developments, or potential annexation.

2026/2027 OVPD Strategic Plan

Focus Area: Facilities and Equipment Readiness

Ensure public safety facilities, vehicles, and equipment meet current and future demands, enable efficient operations, and a safe environment for all.

Goal: Maintain modern, safe, and efficient police facilities, vehicles, and equipment through proactive planning, collaboration, and innovation.

Strategies:

- Collaborate with Oro Valley Public Works on design to ensure new police facility will meet current needs while allowing capacity for growth.
- Continue collaboration with Oro Valley Public Works in ensuring fleet readiness.
- Assess and evaluate current and future equipment needs to keep OVPD officers properly equipped to enable safe and effective performance.
- Collaborate with the Innovation and Technology Department to evaluate and potentially integrate the use of approved artificial intelligence applications to streamline work where appropriate.
