POLICE DEPARTMENT

CASES AND STATISTICS

Case 1

On the morning of December 16, an attempt to locate was dispatched, referencing a reckless driver in a black Chevy Silverado heading south on Oracle Road from Rancho Vistoso Boulevard at over 90 mph. An officer was on a traffic stop on Oracle Road just north of La Reserve Drive when he observed the suspect vehicle drive by at an extremely high rate of speed, weaving through traffic and then passing vehicles on the shoulder of Oracle Road. The speeding truck then crossed into the northbound lanes of traffic while still heading south where a head-on collision occurred in front of the Target shopping plaza with a maroon Chevy Silverado driven by the victim. The drivers of both vehicles were declared deceased on scene and no other passengers were in either vehicle. The drivers both had to be extricated from each vehicle due to the excessive amount of front end damage to both trucks.

Case 2

On December 19, an officer was conducting a business check at Kohl's. While circulating the rear of the business, the officer saw a subject leaving the emergency exit at Kohl's with stolen merchandise. The officer attempted to stop the subject, but he ran off. The officer ran after him and the suspect was apprehended a short time later. The subject was found to be in possession of a stolen firearm and had an active felony warrant out of the Pima County Sheriff's Department. The arrestee was transported to the hospital for possible fentanyl ingestion. He will be booked for shoplifting, prohibited possessor and possession of a stolen firearm, and the felony warrant.

SPECIAL EVENTS AND COMMUNITY INVOLVEMENT

On December 8, **two new OVPD officers graduated** from the Northern Arizona Regional Training Academy in Prescott, AZ. Officer Altimarano and Ryske graduated #2 and #3 respectively in their class.

On December 14, the Oro Valley Police Department's Fraternal Order of Police hosted the annual "Cops and Kids" Christmas shopping event. This partnership with Walmart and generous community members provided Christmas gifts for 23 children in need in our community.







COMMUNITY INVOLVEMENT

As members of the Pima Regional Critical Incident Team, OVPD assisted the Tucson Police Department in two separate fatal officer involved shootings. One took place December 4 and the other December 7. OVPD remains an integral participant in this regional collaborative investigative group.

Single Family Residential Activity


Two new Single Family Residential (SFR) Permits were issued during the month of December compared to four SFR permits issued in November. For the 2022 calendar year, a total of 185 SFR permits were issued compared to 340 issued during the 2021 calendar year.

Permitting Activity

151 total permits were issued during the month of December compared to 238 permits issued in November. For the 2022 calendar year, a total of 2,666 permits were issued compared to 2,533 issued during the 2021 calendar year.

MEETINGS/OTHER NEWS

Planning and Zoning Commission

On January 10, the Planning and Zoning Commission will consider and take possible action on the following items. Please visit OVprojects.com for more information about each project.

- A conditional use permit for a proposed 106,000-square-foot self-storage and retail facility located near the northwest corner of Tangerine Road and La Cañada Drive.
- A proposal for an **office and drive-thru development** located at the northwest intersection of Naranja Drive and La Cañada Drive. The proposal requires four separate, but related applications:
 - * Conditional use permit for the proposed drive-thru
 - Reconsideration of a 2006 grading exception condition
 - A conceptual site plan for the development that includes three office buildings and a drive-thru
 - * Architecture for the office buildings
- A conditional use permit and architecture for a proposed car wash, located on the southwest corner of Oracle Road and Water Harvest Way, within the Oro Valley Marketplace.
- A revision to a **Master Sign Program for the Steam Pump Village Center**, located on the east side of Oracle Road and a half mile north of First Avenue.
- The Commission will receive an update on the Town's efforts in implementing land use and zoning related actions from the **Your Voice**, **Our Future General Plan** and opportunities to participate in the next 10-year update.





Town Council

Council approved short term and vacation rental regulations and ordinances at the January 4 Council meeting.

Board of Adjustment

An appeal of an administrative decision was scheduled to be heard by the Board of Adjustment in early January. The appeal was related to a citizen complaint about a tow truck business, with its large trucks being operated out of a residential property. The business/property owner came to an agreement with the Town to mitigate the matter within a specified time frame, therefore eliminating the need for the case to be heard by the Board.

Neighborhood Meetings

A neighborhood meeting will be held on January 19 for the expansion of Extra Space Storage, located southeast of the intersection of Oracle Road and Hardy Road. The applicant is proposing a Type 2 General Plan Amendment and rezoning to a Planned Area Development (PAD) to accommodate new RV parking and a two-story storage building on vacant parcels north of the existing facility. NEW DEVELOPMENT

In December, Oro Valley was included in a state-wide search for a manufacturing facility in the Industrial Processing and Fabrication industry. The Town was unable to respond because the project required on-site rail service and heavy industrial zoning.

PLANNING PROJECT HIGHLIGHTS

- Preparation is underway for the Town's next General Plan, which is a community-driven, 10-year policy document that
 guides Town decisions and departments. The next 10-year General Plan will be on the ballot in 2026. The first step in the
 process is developing a Community Engagement Plan. Residents can participate in a brief survey to help identify the best
 ways to engage our community. For a link to the survey, click here.
- A pre-application was held on December 22 to rezone a portion of the former Rancho Vistoso Golf Course clubhouse property from open space to recreation. If approved by Town Council, the rezoning will support a new public trailhead for the Vistoso Trails Nature Preserve and the development of a 132-unit multi-family development. Should the project move forward, the next step is to have a pre-submittal neighborhood meeting.

PUBLIC WORKS

BOND PROJECTS

Staff presented a current update to Council at the January 4 Town Council Regular Session.

ENGINEERING/GENERAL PROJECT UPDATES

La Cañada Multi-Use Path: Lambert to Naranja

During the design, it was determined that the roadway centerline was built west of the section line and thus creating a 200-foot-long narrow area between the curb and right of way line. This narrow area is not wide for the multi-use path and thus staff will be meeting with the Cañada Hills HOA and affected homeowners, to discuss a pedestrian and slope easement along La Cañada Drive.

Naranja Drive Multi-Use Path Project

Once the Pima Association of Government (PAG) has added the Naranja Drive MUP into the Transportation Improvement Program (PAG TIP), ADOT can request a Federal ID project number and commence an IGA between the Town and ADOT for administering the project. This IGA will be forward to Council for approval.

Steam Pump Ranch Garage

The contractor will return in January to exchange four temporary windows that were installed in the interim until the permanent windows became available. The Town will also be executing a contract with Cintas for monitoring the fire sprinkler system.

Steam Pump Ranch Bunk & BBQ

The project was advertised with bid proposals due at the end of November. There were no bids submitted. Staff then reached out to Chasse Building Team, who were recently awarded a Job Order Contract (JOC) by the Town. The bid proposal is due January 9.

SR 77 Wildlife

Canyon Fence continues installing the wildlife fence. Rustic Adobe Masonry has poured all wall footings and has block on-site at Big Wash Overlook Place. They have delayed laying the block due to low temperatures overnight. Construction completion is scheduled for late February.

La Cañada Drive - Tangerine to Moore Road (mill/fill)

The Town received three bid proposals at the end of November. All three were higher than the budget amount. Staff is modifying the scope of work (timing) and rebid the project in February.

Pavement Preservation

Two out of the five phases are complete. The remaining phases will be finished in spring when temperatures rise.

Adopt-A-Road Program

96 total clean-ups were completed in calendar year 2022.

FLEET AND FACILITIES

- The contractor has received the generator dock for the Tangerine Police Substation and is scheduled to begin installation the second week in January.
- The Police Patrol Tahoe refresh is progressing with 12 Tahoes now completed.
- The Town Hall Building A generator project is underway. The generator is expected to ship in May.
- Replacement of the Community Center awnings is expected to be complete by January 18.

STORMWATER AND STREET OPERATIONS

La Posada at Pusch Ridge

The former Nakoma Sky development has re-broken ground as the La Posada at Pusch Ridge development located at Lambert Lane and First Avenue. Previous activities as part of the Nakoma Sky development included the Cañada Del Oro Wash soil cement bank protection, Federal Emergency Management Agency Letter of Map Revision and general site grading. The current activities for the La Posada at Pusch Ridge development include cutting in access roadways, setting up stormwater pollution prevention best management practice elements, and site mobilization.


Tranquillo Subdivision

The Tranquillo subdivision located near Rancho Vistoso Boulevard and Del Webb Boulevard has completed the soil cement bank protection work along the west bank of Big Wash. Pedestrian, access control, and safety elements remain to be installed, but the underlying bank protection infrastructure is in place and has been accepted by the Pima County Regional Flood Control District and Oro Valley Stormwater Utility groups. Site grading, utility installation, and drainage infrastructure work elements continue.

ADMINISTRATION

Vistoso Trails Nature Preserve

The Master Planning process continues into 2023 with a site visit from Liz Cole from Sites Southwest. Liz will be meeting with stakeholders, staff and community members to review the findings report, ensuring they captured the community feedback as well as identifying site findings. A community open house will be held in the Garage at Steam Pump Ranch on Wednesday, January 25, from 10 a.m. to 6 p.m. Meetings with stakeholders and staff will be on Thursday, January 26 at Town Hall. The first draft will be presented to the Parks and Recreation Advisory Board at its February 21 meeting (via Zoom) and to Council on March 15 (via Zoom).

AQUATICS

Kelsey Ottosen, the Assistant Aquatic Manager for the Oro Valley Aquatic Center, completed her **Lifeguard Instructor Trainer (LGIT) certification** through the American Red Cross. Kelsey is now one of just a few people to have this certification in Southern Arizona. This allows the Aquatics Center to certify and recertify Lifeguards and LGI's, saving the Town time and money.



The **Oro Valley Aquatic Center improvement project** is progressing nicely. All the old pool filters and plumbing has been removed as well as the recreation pool heater. The additional concrete pads and footers have been poured, and the east pump room wall has been removed. The Olympic Pool has been drained and staff has begun the process of deep cleaning the pool plaster and tile. The next steps are receiving the new filters and installing the new plumbing lines.



COMMUNITY AND RECREATION CENTER

The Community & Recreation Center (CRC) now has **over 2,500 members**, which is the most the facility has had since 2018. The facility anticipates matching all-time membership numbers as it welcomes new and returning members in 2023.

With the closure of the Oro Valley Aquatic Center, the **CRC** has opened its doors to **Aquatic Center members** and swim teams. For the month of December, the CRC has recorded nearly 400 check-ins from Aquatic Center members. Additionally, the facility has been opening at 5 a.m. Monday through Saturday to accommodate the swim teams. The CRC will continue to welcome this usage through the month of January.

The CRC will be hosting another trivia event on January 14 at the Overlook Restaurant from 4-6 p.m.

PARK MANAGEMENT

The **playground at Riverfront Park will be closed** January 9 through February 3 for repairs and replacement of safety surfacing. Parks staff will be replacing worn stairs and decking associated with the play structure. The recycled rubber fall surface will be replaced with wood fiber. The work includes the addition of new irrigation and trees near the playground.

RECREATION AND CULTURE

The third hike in the Oro Valley Hiking series will be on January 7 with a hike up Ventana Canyon to Maiden Pools.

January 14 is **Second Saturdays at Steam Pump Ranch** with the Heirloom Farmers Market, craft vendors, live music and a kid's craft.

January 14 is also the **Beyond Hike with Beyond – Tucson**. Beyond is a broad-based coalition of Southern Arizonans including hospitals and health organizations, environmental advocacy groups, community centers, outdoor recreation groups, and others working together to support mental and physical health.

General Manager Bernie Eaton will be leaving El Conquistador Golf,; his last day is January 17. Bernie has taken a position with the PGA as their Southwest Section Executive Director. The membership was notified in December. Kristy Diaz-Trahan will work closely with Indigo Regional Director Tony Marino in the selection of the new GM. Indigo will be conducting a nationwide recruitment.

As of December 19, there were 341 Full Memberships with 9 Corporate Memberships. The **marketing focus for January** will continue to be on full-time and corporate memberships. Staff is continuing with the Golf Channel TV advertising for Pusch Ridge and the 36 Hole Facility. January events include Friday Dinners at The Overlook on January 6 and 20, Member Trivia Night on January 13, Beat The Staff Scramble on January 21, and Sunday Brunch on January 22.

January projects include rye grass fertilization, poa annua weed suppression on greens, wash clean up on #4 Conquistador, drain repair on #18 Conquistador, herbicide applications on all bunker faces and green surrounds, sprinkler head edging on Cañada, tree pruning and detail cleanup work in landscaping areas.

WATER UTILITY

METER OPERATIONS

For calendar year 2022, the Utility added 190 new service connections. The Utility now has a total of 21,242 service connections.

As of December 31, for fiscal year 2022-23 (July-December), the Utility has added 128 new service connections.

WELL REHABILITATION — CAPITAL IMPROVEMENT PROJECT

Water Utility staff continues to successfully implement this year's Capital Improvement Program. Well rehabilitation work is currently underway on two of the Utility's production wells. Work includes pulling the pump, assessing the condition, performing repairs if needed, cleaning and reequipping the well with a new pumping unit. Once completed the well and equipment should provide over a decade of reliable service.



BEHIND THE METER NEWSLETTER

Technology updates

The I&T team is working to enroll every user with a Town of Oro Valley account in multi-factor authentication (MFA). MFA has become an industry standard for cybersecurity and is one of the most effective tools available to prevent unauthorized access on Town accounts. To date, approximately half of the Town staff have been enrolled, with the remaining departments completing enrollment in January.



Emergency Management and Safety

Emergency Management facilitated a fire drill for the Town Hall complex on December 15. Outcomes from the drill will be utilized to update the Town Building Evacuation Maps, Continuity of Operations Plans, and Safety Training.

New and updated first aid and AED equipment is being placed in Town occupied facilities. The updated first aid cabinets offer a variety of life saving equipment in addition to some basic over-the-counter medications for staff use.

OV Peak Performance

The Town's Continuous Improvement Analyst presented a Peak Performance program highlight to the Senior Management Team on December 15. The presentation highlighted the benefits of focusing on process improvement within an organization including increased quality and efficiency, eliminating bottlenecks in operations, reducing costs, waste, and redundancies, and improving both internal and external customer satisfaction. Successfully implemented process improvement initiatives from OVPD, Parks & Rec, and Finance were also highlighted. Between all three initiatives, the annual savings to the Town will be \$19,348 per year or 38.5 workdays' worth of time saved per year.

Oro Valley Youth Advisory Council (YAC)

The YAC members were honored at the Oro Valley Volunteer Appreciation Reception on December 15 at the Hilton El Conquistador Resort.




