Town of Oro Valley | April 2024

I am pleased to provide you with an update on the progress of the Naranja Park Expansion Project, a testament to the Town of Oro Valley's dedication to fostering a wide range of recreational opportunities for all.

I'm thrilled to share that the construction project is nearing completion, marking an exciting phase in the evolution of Naranja Park. These additions, including a splash pad, pump track for bicycles, and skate park, alongside two new multi-purpose fields and four new pickleball courts, will enhance recreational experiences for residents of all ages. Additionally, the completion of the Arizona Heroes Memorial this summer will serve as a poignant tribute to first responders, military members, and healthcare workers within our park grounds.

These new features complement our existing amenities and enrich the recreational activities available to the community. From archery trails and dog parks to soccer fields and a remote-control plane airfield, Naranja Park caters to a wide range of interests across our community.

The journey from a gravel and sand pit used to make concrete in the 1970s to the valuable community asset it is becoming today is a remarkable one.

I extend my gratitude to the former Town Council members who recognized this potential and initiated the purchase. And under the current Council's leadership, Oro Valley has remained steadfast in our commitment to this project. Despite facing challenges such as budget constraints, we have navigated through the planning process with resilience, ensuring that the project remains on track. I commend our Councilmembers for making difficult decisions to adjust the scope of the project when necessary, demonstrating their dedication to fiscal responsibility. And we commend our Public Works staff for implementing these adjustments seamlessly. The Town also secured an additional \$1M grant to further enhance the park's amenities.

A grand opening event is currently being planned for Saturday, May 18. The Town will soon extend an invitation to all residents to join us in celebrating this significant milestone. Stay tuned and we hope you will join us!

Let's come together to embrace the spirit that defines our community, embodied in our Town slogan, "it's in our nature."

Thank you to everyone involved in making the Naranja Park Expansion Project a reality. Your dedication and support have been instrumental in shaping the future of this beloved park.

PW Transit - Number of Passenger Trips Provided & Passengers per Hour














Town Clerk - Public Record Requests Initiated




Town Clerk - Time Utilized to Process Public Record Requests





POLICE DEPARTMENT

CASES AND STATISTICS

Case 1

On March 3, officers responded to the area of Oracle Rd. and Cool Dr. for a vehicle vs. pedestrian collision. A vehicle that was exiting the parking lot struck a pedestrian that was walking southbound. The pedestrian was transported to the hospital with critical injuries. The driver was checked and showed no signs of impairment. The investigation is ongoing.

Case 2

On March 5, Officer Farmer contacted a vehicle that had been stopped at the fuel pumps of a local business for an extended period of time. He located a female passed out in the driver seat of the vehicle in possession of drug paraphernalia. Further investigation led to the recovery of over 6,000 suspected Fentanyl pills, 5.2 grams of suspected Methamphetamine, and 1 gram of suspected Cocaine. She was booked into Pima County Jail on numerous charges.

Statistics/Information

OVPD had the opportunity to work with our local and regional friends to host a Fraud School. This class was designed to make our community members aware of the types of scams out there and how to protect themselves from being a victim. The class was in partnership with ROSE, which is an organization that helps protect our elderly population, and BMO bank.



SPECIAL EVENTS

OVPD hosted the annual Kicks for a Cause Kickball Tournament. This Guns and Hoses event had fire and police competing for the coveted "Kicked our Butt" Cup. Our neighbors at Marana PD took the cup back for the fire department, so we appreciate that.



STATISTICS

Single Family Residential Activity – 20 new Single Family Residential permits were issued during the month of March, compared to 21 SFR permits issued in February. Year to date (YTD), 51 SFR permits have been issued since the beginning of the year, compared to 24 issued during the same period in 2023.

Permitting Activity – 194 total permits were issued during the month of March, compared to 187 permits issued in February. YTD, 577 total permits have been issued since the beginning of the year, compared to 604 issued during the same period in 2023. Below are charts showing overall activity for the last six months:

OTHER NEWS

Tourism

Tourism staff have met with the managers of El Conquistador and Westward Look to discuss group lead development and booking strategies, supporting budgets, and additional strategies to ensure their success after the Town discontinued its operating agreement with Visit Tucson.

The Oro Valley Tri/Duathlon Festival 10th Anniversary took place at JDK Park. The event was sold-out with many athletes coming from across the country, for a positive economic impact with contracts at our local hotels and the HQ Hotel at Fairfield Inn and Suites.

Short Term Rentals (STR)

STR statistics as of April 1, 2024:

- 1. There are currently 312 STRs operating in Oro Valley.
- 2. Staff have identified 92.6% of STRs that have identified street addresses.
- 3. 96% of STRs are included as the entire single family residential (SFR) unit with only 4% renting out part of an SFR.
- 4. SFRs constitute 68% of STR rental types. 15% are MF units. 17% are unidentified to date.

Code Compliance

Code Compliance was able to work with the management company for 10420 N. La Cañada Drive to repair the deteriorated parking lot. The potholes were repaired and the parking area was resurfaced and re-striped.

PLANNING PROJECT HIGHLIGHTS

Oro Valley residents continue to show their commitment to the Town's future. More than 3,000 people responded to the Big Community Survey to share their priorities and expectations for the future. This represents a 384% increase from the last 10-year plan survey done in 2013.

The survey response will be combined with comments received online or in the community to establish the community's vision and values for the future. To date, community members have provided 4,377 comments (46% increase from 2013) to help create OV's next 10-year community action plan, known as OV's Path Forward.

PUBLIC WORKS

BOND PROJECTS

Naranja Park Expansion Project

Haydon and subcontractors are working together toward completing the final steps in the construction and opening the improvements. The final pavement was placed last week, although some work remains on the south Musette improvements. Concrete sidewalks were placed, connecting the playground to the new splash pad and then up to the new parking and fields. The Musette wash crossing work is on schedule and proceeding well. Signage was added on Tangerine Road to help guide residents to the new north entrance to the park. Plans are being finalized for opening the south entrance and amenities in April and a grand opening event in May.





GENERAL PROJECTS UPDATES

Oro Valley Town Court Expansion


A pre-construction meeting was held, and a construction schedule was submitted by Barker Construction. Preliminary review of this three-phased project has a start date of April 2, 2024, with an anticipated competition of April 2025. Staff is working on a communication plan to enhance situational awareness to visitors and staff coming to the campus during the project to ensure safety of pathways to access Town services.

Town Wide Space Needs Study

The project consultant, Gensler Architecture and Planning, is analyzing all of the gathered data. Interviews have been completed and work to produce a draft report is underway.

Community and Recreation Center New Entry Way and Elevator

This project is moving forward. As more of the demolition continues and establishment of the elevator shaft gets underway, unforeseen challenges have developed. These challenges are being addressed with the team and multiple solutions are being considered. These challenges will contribute to a slight delay to the completion of the project, but staff and the contractor are determined to evaluate all possible solutions to constrain the budget to allocated funding.



ENGINEERING

Capital Improvement Projects

- Naranja Multi Use Path Final project assessment review completed 3/19. Revised alignment at two locations (Masters Circle and Desert Wisper Way) based on public input emails.
- Tangerine Road Yellow Flashing Arrow at the La Cañada & First Avenue intersections. Stage II plans and estimate are in review.
- Westward Look Multi Use Path Contractor has submitted a cost proposal to repair and overlay MUP waiting for authorization to proceed on awarding contract.

Pavement Preservation

- Phase 5- VSSI International will apply Gilsonite on Lambert Lane (from Rancho Sonora to La Cholla Boulevard) and on Calle Concordia (from Oracle Road to Marne Place) – Work started in March.
- Phase 6 Pavement Restoration Incorporated will apply a reclamite surface treatment on the La Cañada Subdivision Work will start in late April.
- Phase 7 Liquid Road treatment by KE&G Work will start April 15:
 - Calle Loma Linda
 - Placita Delo Oro Patio Homes
 - Rancho Feliz
- Phase 8 Crack Seal the La Cañada multi-use path from Tangerine Road to Moore Road:
 - Received five bid proposals; Empire Paving apparent low bidder

Planned Projects and Tasks

- Vistoso Trails Nature Preserve Restroom: The doors have been installed and inspections have been completed. Staff is awaiting the stucco inspection. All plumbing is completed except for setting the toilets.

TRANSIT


Five of the long-awaited buses have arrived. These buses will be equipped with cameras and then placed into service. Three additional buses were awarded through a grant partnership with the City of Tucson; we are still awaiting delivery.

STORMWATER & STREET OPERATIONS

Stormwater Utility

The Pima County Alert System has recorded 4.17 to 5.67 inches of rainfall within the Town of Oro Valley for the calendar year 2024 at their rain gauge stations. This amount tracks with the annual rainfall average of 4.1 inches for Oro Valley between January through March and exceeds it by more than 1.5 inches in the northeast section of the Town. Rainfall has been mild with minimal drainage complaints being filed with the Town. This rainfall has also allowed vegetation to steadily grow through the winter and into the spring. If weather patterns hold to traditional norms through the spring and a drying out period takes hold, the enhanced vegetation growth could turn into fuel to kick start forest fires.

Street Operations

- Street crews have completed sidewalk repairs in the Copper Creek II (1-235) subdivisions as well as on La Cañada Drive between Naranja and Tangerine.
- Crack sealing continues in the Suffolk Hills (1-195) subdivision.
- Street crews have completed removal and replacement of failing asphalt on Lambert Lane at the Fry's Shopping Center entrance as well as on Chelsea Court within the Suffolk Hills (45-107) subdivision.
- Arterial, collector, and residential sweeping continues townwide in addition to monthly multi-use path sweeping.
- Pima County Development Services has approved the permit for the Operations Laydown Yard storage building on N. La Cholla Blvd. Surveying and dirt work for slab preparation began the week of March 18.
- Street crews continue to be busy patching various new and existing potholes throughout the Town due to the exceedingly wet start to 2024.
- Townwide right-of-way landscape maintenance continues at various locations by Town staff, ADC crew, and contractor crew
 as vegetation continues to be extremely active due to the significantly wetter than normal start to 2024 and with the recent
 warmer temperatures.

PARKS & RECREATION

ADMINISTRATION

April is here and that means a busy month of 50th celebrations! On Saturday, April 6, the celebration will begin with the 50th Anniversary Parade at 9am. The parade will start in front of Ironwood Ridge High School and end at the library parking lot. Our celebration will continue with the 50th Celebration Event on Saturday, April 13 starting at noon. The event will include stage time for local groups, activities, town booths, food trucks, and the band Voyager. The event will culminate with a fireworks display at 9:30pm.

Planting 50 Trees for 50 years will also be part of the April celebrations. On Friday, April 26 at 10am Town Council will be planting a tree at Town Hall. On Saturday, April 27 at 9am the community is invited to join staff at any of the following locations: Naranja Park, JDK Park, Steam Pump Ranch, and Riverfront Park. Staff will be waiting at the blue tents ready to plant the remaining 49 trees with community members. Our 50th mural work begins in early April. The artist has been selected and PRAB has worked with staff on the design. The mural will be on the southwest corner of the Oro Valley Aquatic Center. Part of the mural will face Calle Concordia, while the other side of the mural will face the parking lot entryway. Staff is excited to see the final product!

Progress continues on the Naranja Park Project, Elevator Project at the Community & Recreation Center, and restroom improvements at Honeybee Canyon Park and Vistoso Trail Nature Preserve. The Naranja Park Tangerine Road entrance remains the sole access point to the park until mid to late April. The Naranja Drive entrance remains available for access to the archery range only.

AQUATIC CENTER

Martin Tuck has been hired as the new Facility Manager of the Oro Valley Aquatic Center. Martin comes to the Town after working over 25 years at the University of Arizona in several aquatics related positions, most recently as Director of Aquatics of the Hillenbrand Aquatic Center.

RECREATION AND CULTURE

March was a busy month in the Parks and Recreation Department. Recreation and Culture provided a number of events and programs including Spring Break Nature Camp (*pictured*), Bike Swap Sell, and Easter Eggstravaganza.

The Movie at the Ranch in April will be The Super Mario Bros. Movie. Second Saturday in April has the Heirloom Farmers Market, Makers Market and Pusch House tours. Archeology Southwest and the Oro Valley Historical Society will be at Steam Pump Ranch interpreting history and primitive living skills for the public.



Lifetime learning with Gadget Guidance and the Single Senior Mingle continue in April. The Friday night concert series is in full swing as well.

The Adult Kickball league kicks off in April for a 7-week season culminating in a playoff tournament in June.

COMMUNITY AND RECREATION CENTER

The pickleball shade construction project was completed last month, and staff held a celebration to commemorate the project on Friday, March 9 (*pictured*). The shade project includes two 20-ft x 20-ft shade structures, to match existing shade at the tennis and pickleball facilities.

The CRC will be hosting its annual pickleball tournament April 4-7. This fifth annual event will feature nearly 300 players for some fun and exciting competition. This year's event is an OV 50th anniversary branded event and each participant will receive a complimentary 50th t-shirt, thanks to event sponsor Lisa Bayless Realtor.



Movies on the Lawn at the Community & Recreation Center will return on April 6. This month's movie will be the 1989 sci-fi adventure film, Back to the Future Part II. This free community events will take place once a month through September and will be hosted on the backside of the facility near the driving range. Movies start at sunset.

El Conquistador Tennis will be hosting a USTA Level 3 National Tournament March 16-18 at the CRC and Pusch Ridge Tennis Facility. This event will feature high level competition from young athletes aged 18 and under.

INDIGO GOLF

Golf Rounds for April are forecasted for 8,250 rounds at the 36-hole facility and Pusch Ridge is forecasted for 2,600 rounds of golf. April is generally a month with great weather, comfortable temperatures, and a later sunset time, which makes it a prime month for golf.

As of March 19, we have 380 Full Memberships with 16 Corporate Memberships. The marketing focus for April will continue to focus on full-time, monthly and corporate memberships.

April events include weekly Ladies, Men's and Couples competitions and the WGC Club Championship April 16. We will be hosting 13+ social events during the month, including Friday Night Fish Fry, Republic Women's, and a wedding on April 19. We have two larger golf tournaments in April: Golden Retriever Event April 14 (120 players) and U.S. Marshall Event April 27 (144 players).

April projects include: greens top dressing, desert herbicide application, greens fertilization, sprinkler edging, cart path cleaning, desert cleanup along homes where accessible, tree pruning, verti-cutting, and pre-emergent application in rough.

April maintenance activities include: tree pruning, edging valves, gopher control, herbicide application, seed head application, greens fertilization, and bunker edging.




CIP - CAPITAL IMPROVEMENT PROGRAM

Water Utility staff continues to implement this year's Capital Improvement Program.

Big Wash Reservoir Rehabilitation

The Big Wash 250,000-gallon reservoir is one of two reservoirs located near the Marketplace. This reservoir was inspected in the winter of 2023 and is slated for rehabilitation this winter. Closer inspection of this reservoir revealed the need for more extensive rehabilitation work than originally planned. Engineering staff is working with a consultant structural engineer to determine the appropriate course of action to best rehabilitate this municipal water asset.





WATER OPERATIONS

Annual reservoir cleaning and inspection program

Every year during the winter months, Water Operations contracts with a diving company certified to clean, inspect and evaluate the condition of municipal water reservoirs. This annual inspection ensures the water reservoirs are in good working order and are prepared to provide safe, reliable, uninterrupted service.

Water Utility staff are continuously performing maintenance work on the Water Utility's production assets.






ADMINISTRATION

FINANCE

The Town continues to perform as expected from a Town-wide financial perspective. Total Town-wide revenues are up \$3,733,947 through January 2024, in comparison to January 2023. Meanwhile, total Town-wide expenditures are greater than January 2023 by \$6,353,200. Capital is the primary driver of the increase in spending from the prior year, as it accounts for \$4,770,139 of the \$6,353,200, or 75%. Personnel and Operations & Maintenance (O&M) also continue to outpace last year's outflows through Jan. Total estimated Town-wide Fund Balances through January 2024 are \$83,411,272, which is about \$5.77 million less than the Town carried into the fiscal year. This reduction in fund balance is primarily a function of the large capital projects being executed and the continued spenddown of ARPA and parks and recreation bond monies.










OV Youth Advisory Council (YAC)

Youth Advisory Council applications are currently open and being accepted through April 12. To date, 25 applications have been received to fill five vacancies from graduating seniors.

Emergency Management

The Town Incident Management Team (IMT) conducted a communications drill on March 22. A total of 34 phone alerts were sent with approximately 60% answering live (*chart*). All members of the IMT acknowledged receipt of the alert message. Moving forward, the IMT will utilize a hybrid approach for communications, utilizing our alert system to reach email, text messages and phone calls. The Town IMT is scheduled for additional trainings heading toward a tabletop exercise in Summer.



On March 28, Town Emergency Management and Safety hosted a CPR/AED Training for staff requiring certification as part of their job duties. Forty staff members from Public Works, Parks & Rec, OVPD, and Courts were certified. Additional trainings for interested staff will be made available in Summer.

INNOVATION AND TECHNOLOGY

In March, the Information Technology department kicked off their engagement with Crexendo, the Town's selected vendor for the phone system. The new phone system will replace the Town's aging phone system. This new system will allow additional functionality for the Police Department, Transportation, and Inspectors. The new system will in place by the end of April.

IT has been working with the Arizona Department of Homeland Security regarding the State and Local Cyber Readiness Program grant. The Town has been awarded licensing for a cybersecurity training system. This system will be used to increase cybersecurity awareness for the Town and provide additional cybersecurity training opportunities for all IT professionals.
