Variance for fire sprinkler requirement:

If a 3/4 x 3/4-inch residential water meter is required solely due to a fire sprinkler requirement, the impact fees paid will be equal to those of a 5/8 x 3/4-inch meter; however, the meter fee will be that of a 3/4 x 3/4. This requirement must be authorized by the Town of Oro Valley Building Permit Dept.

Meter & impact fees for a variance: \$339.65 + \$6,387.00 for a total of \$6,726.65
