RESOLUTION NO. (R)22-37

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF ORO VALLEY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON AUGUST 2, 2022

WHEREAS, the Town of Oro Valley, Arizona did hold a Primary Election on the 2^{nd} day of August, 2022, for the election of one (1) Mayoral seat and three (3) Councilmember seats; and

WHEREAS, the election returns have been presented to and have been canvassed by the Town Council; and

NOW THEREFORE, BE IT RESOLVED by the Mayor and Council of the Town of Oro Valley, Pima County, Arizona, as follows:

SECTION 1. That the total number of ballots received for the Oro Valley Primary Election was 18,189, representing 51.12% of the registered voters.

SECTION 2. That the votes cast for the candidates for Mayor and Councilmembers were as follows:

SECTION 3. The number of votes required at the Primary Election to be declared elected was calculated by adding all of the votes cast for all candidates for the office, dividing by the number of seats to be filled and then dividing the result of the calculation by two and rounding to the highest whole number. In order to be declared elected as Mayor, a candidate needed to receive 8,731 votes. To be elected as a Councilmember, candidates needed to receive 7,912 votes.

SECTION 4. Joe Winfield having received more than the number of votes required, is hereby declared elected to the Office of Mayor and shall serve a four (4) year term commencing November 16, 2022 to November 4, 2026.

SECTION 5. Melanie Barrett, Joyce Jones-Ivey and Josh Nicolson, each having received more than the number of votes required, are hereby declared elected to the Office of Councilmember and each shall serve a four (4) year term commencing November 16, 2022 to November 4, 2026.

SECTION 6. As the Mayoral seat and all three (3) Councilmember seats have been filled, the General Election scheduled for November 8, 2022 is hereby cancelled.

SECTION 7. Where it is necessary for the preservation of the peace, health and safety of the Town that this Resolution become immediately operative, this resolution shall be in full force and effect immediately upon its adoption.
