TOWN MANAGER'S EXECUTIVE REPORT Town of Oro Valley | December 2023

As we enter the holiday season, I'd like to share a snapshot of charitable efforts by our dedicated staff throughout the year.

Our October Food Drive was in collaboration with Interfaith Community Services. The collective efforts of Town of Oro Valley Staff resulted in a donation of over 900 pounds of food. The Transit team deserves special recognition for filling two large bins, a testament to the generosity that flows through Oro Valley.

In December, we participate in the Children's Advocacy Center's Toy Drive, open to both the public and staff to participate in. For more information or to get involved, visit <u>cacsoaz.org</u>. Our police department also presents "Cops and Kids," an event in which 25 local kids get to go shopping with a cop for gifts for their family. All money used to purchase the gifts comes from money raised from our generous community.

Parks and Recreation hosts the Round Up at the Ranch 5K and the Hot Cocoa 5K races annually. 50% of the proceeds from each of these events benefit the Town's Youth Recreation Scholarship Fund, which is used for camp/program registration for OV families in need. Last year, more than \$8,500 was raised for this fund. The next 5K event will take place Jan. 1, 2024, at Steam Pump Ranch. And Parks and Rec's annual shoe drive at CRC takes place in January in partnership with Impact of Southern Arizona. Nearly 220 pairs of shoes were donated to those in need in the last drive.

Earlier this year, the Guns and Hoses kickball tournament hosted by Oro Valley Police Department and Golder Ranch Fire District raised more than \$8,000 in support of Project Grad, a program designed to give high school graduates a safe alternative to celebrate their special night. Our next charity kickball event will be held on March 9, 2024, at Riverside Park.

Staff also rolled up their sleeves in April and participated in an Earth Day beautification event, removing invasive species from the Vistoso Trails Nature Preserve. Additional volunteer opportunities are available year-round with the Keep OV Beautiful, Adopt-A-Road and Adopt-A Trail programs; to learn more about ongoing efforts to Keep OV Beautiful, <u>visit our website</u>.

These initiatives, alongside our ongoing commitment to hosting Blood Drives with the American Red Cross (3x/year), showcase the heart and compassion of our community. In 2023 alone, TOV Staff donated 65 pints of blood from 64 donors. Each pint of blood collected can potentially save up to three lives, underscoring the profound impact of our collective contributions.

I also want to convey my appreciation for all our volunteers, board and commission members who work tirelessly to provide invaluable services to our community. These selfless individuals, working across various programs and organizations, embody the community spirit that makes Oro Valley exceptional.

I wish everyone the happiest of holidays and I am excited 2024 will be another remarkable year for Oro Valley.


Operations and Maintenance Expenditures per Square Foot of Buildings Maintained







CASES AND STATISTICS

Case 1

OVPD officers located a stolen vehicle at a local business. A coordinated plan was made to effect an arrest on the suspect in a manner that reduced the opportunity for the suspect to flee, and keep officers, the public and the suspect safe. As a result of their planning, the suspect was taken into custody without incident. Further investigation revealed the suspect had felony warrants from Florida and was believed to be involved in numerous other Organized Retail Thefts from the Phoenix area, as well as California and Nevada. He was also in possession of over 100 counterfeit identification cards. He was booked into jail for the felony warrant and 12 local felony charges.

Case 2

A one motorcycle fatality collision occurred on November 12th. The collision scene was reported by a citizen out for a walk. It appears the collision occurred sometime the previous night but was not discovered until daylight. The rider failed to negotiate a curve, and left the roadway, and then crashed through a cement wall.



Single Family Residential Activity – 13 new Single Family Residential Permits were issued for the month of November compared to 11 SFR permits issued in October. Year to date, 115 SFR permits have been issued since the beginning of the year compared to 183 issued during the same period in 2022.

Permitting Activity – 151 total permits were issued during the month of November compared to 185 permits issued in October. Year to date, 2,223 total permits have been issued since the beginning of the year compared to 2,515 issued during the same period in 2022.

BOND PROJECTS

Naranja Town Park Expansion Project

Concrete work continues with the added (98) pole foundations being completed and significant progress on the sidewalks and curbs around the parking lots. Grading work is on-going in the parking areas and along Musette north to Tangerine, which will be paved by the end of December. The photos below show vertical curb being installed with a curb machine. The pickleball courts are near complete, with the exception of the nets and paint installation. Splash pad construction is fully underway with the underground piping being installed for each of the toys or features. Skate Park construction will begin once the drain piping and underground improvements in that area are completed.

Naranja Multi-Use Path: La Cañada Dr. to First Avenue

Design phase is underway, project kick-off meeting was held on 10/5. The topographic survey was collected aerially the week of 10/9. EPS is currently working on the Preliminary Initial Site Assessment (PISA) to be completed by 12/15/23. The PISA will include a preliminary horizontal and vertical alignment of the MUP. EPS is coordinating with sub-consultants and ADOT for environmental, geotechnical, ROW, and Utility clearances. Final plans will tentatively be ready for bid on 9/14/24 with construction starting December 2024 or January 2025.

- Vistoso Trails Nature Preserve, Restroom: Hark GC has been selected to perform the work; however, the scope may need to be reduced to meet budget.
- Town Hall, Building F, LED Lighting Upgrade: The Main Police Station Lighting upgrade is in progress and is 95% complete.
- Town Hall, Building F, Communications Server Room circuit tracing: The site-work has been completed. The contractor is drafting the report and diagrams.


Unplanned Facility Projects and Tasks

- **Community and Recreation Center, Overlook Kitchen, Grease Trap Replacement:** We've received approvals for grease trap permits. This project was published with the elevator RFP as an add alternative.
- **Golf Maintenance Septic Repairs:** A Kittle Design and Construction has been contracted to design the connection to the sanitary sewer and will be providing an estimate for construction with the plans.
- Town Hall Map Kiosks: Map replacement pending delivery by the vendor.

STORMWATER & STREET OPERATIONS

Stormwater Utility

The Oro Valley Stormwater Utility hosted a kickoff meeting with our partners at the Pima County Regional Flood Control District for the Canada Del Oro Wash Levee Augmentation Project on November 17, 2023. This project is in response to wildfires that have impacted watersheds in the Santa Catalina Mountains and potentially increasing flow amounts making their way into the Town of Oro Valley and further downstream. The County has applied for and received approval for a Hazard Mitigation Grant Program award through the Arizona Department of Emergency and Military Affairs and is moving into contractor solicitation. The \$2.3 million project is anticipated to begin construction in Spring of 2024 and be completed in the Fall of 2024. Improvements consist of kickwalls, pavement lifts and berms to provide additional freeboard along the CDO Wash Levee from La Cañada Drive to Oracle Road, which will in turn increase capacity of the channel and contain potential flow increases. Oro Valley staff from the Stormwater Utility, Engineering and Right Of Way, and Parks and Recreation were invited to participate.



Street and Drainage Operations

- Street Crews have completed sidewalk repairs in the Rancho Vistoso Neighborhood 7 subdivisions in addition to various other locations around town.
- Crack Sealing continues within the Copper Creek I Subdivision.
- Street Crews will continue to place some small keystone landscape retaining walls at the toe of the slopes of the E Palisades Road MUP in order to limit erosion and sediment from collecting on the MUP.
- Crews have completed misc. erosion repairs along the north and south sides of Naranja Drive between La Cañada and First Avenue.
- Quarterly dirt road grading has been completed on W limewood Drive and W Linda Vista Blvd.
- Post-Monsoon sweeping of all arterial, collector, and residential streets continues townwide in addition to monthly MUP sweeping.
- Townwide right-of-way landscape maintenance continues at various locations by Town staff, ADC Crew, and Contractor crew.

PARKS & RECREATION

ADMINISTRATION

The new Parks & Recreation Director, Roz Epting, joined the team on November 6th. She is currently being updated on daily operations and ongoing projects.

On November 14th, a meeting was held for the Parks & Recreation Advisory Board. This marked the last meeting for the Board Chair, Matthew Wood, who had served two (2) terms on the Board.

The Historic Preservation Commission has scheduled their next meeting for Monday, December 4th, at 5pm in the Hopi Room.

<u>AQUATICS</u>

On November 30 - December 3, the Oro Valley Aquatic Center will be hosting the Winter Lights Swim Meet presented by the FAST swim team. This annual event attracts over 600 athletes and their families from across the state.

The Oro Valley Aquatic Center currently has over 500 members even as we are now in the winter months. In addition to members ships, the facility serves 200 swim team members daily Monday – Saturday.

On December 25, the Oro Valley Aquatic Center will be closed in observance of the Christmas holiday.

RECREATION AND CULTURE

The Oro Valley Hiking series continues to be popular. Participants will be enjoying the outdoors as they head up into Pima Canyon to the first dam for December's hike.

The Second Saturday Makers Market at Steam Pump Ranch on December 9th will be a great place for people to pick up those hand-crafted gifts for the holidays. The weather is perfect for a morning of shopping and a quick picnic at Steam Pump to start the day.

Continuing programs throughout the month include lifetime learning opportunities with Gadget Guidance and the Single Senior Mingle.

COMMUNITY AND RECREATION CENTER

The Community and Recreation Center will be hosting its annual holiday event, SnOV on Thursday, December 21 from 5-8 p.m. This free community event includes games, crafts, food and drinks for purchase, a showing of the original Dr. Suess's the Grinch Who Stole Christmas, a visit from Santa, and real snow! Staff anticipate approximately 1,500 community members will be in attendance.

The CRC hosted the Turkey Trot Pickleball Tournament November 17-19. The tournament featured all levels and men's, women's and mixed divisions. The tournament totaled over 260 registrants over three days. While the tournament did provide a competitive opportunity, the main goal was to provide a fun and exciting event for the local Oro Valley players. The next tournament is scheduled for late March and will be done in concert with the Town's 50th anniversary.

In November, the CRC began expanding group fitness classes in the Sunset Room, which is the banquet room located near the Overlook Restaurant. As of now, there are seven classes per week offered in this space and staff will continue to look for additional program opportunities to support the increased membership numbers during the winter months.

The facility will have special hours during the holidays. It will be closed all day on Christmas and New Year's Day and closed at noon on Christmas Eve and New Year's Eve.





PARK MAINTENANCE

Planned activities for the month of December include:

Naranja Park – Fall/Winter field maintenance continues. Mowing, fertilization, and irrigation management. Continued maintenance on existing dog park and newly sodded large dog park. Rolling and compacting the existing soil surrounding the sod to be added to existing maintenance practices. Replacement of play structure viewing windows (bubble panels) to be completed in the first to second week of December. Sports field soil sampled and tested on sports fields to adjust and modify our current fertilization program.

Toured with the new Parks Director Rosalyn Epting around all 24 properties and discussed all aspects of Parks Management.

Working on detailed field maintenance schedule for all sports fields. To be completed before the end of December.

INDIGO GOLF

Golf Rounds for December are forecasted at 6,675 rounds at the 36-hole facility and Pusch Ridge is forecasted for 1,800 rounds of golf. All 45-holes of golf are open for play. This is the time of year where we generally start having frost in the morning and potential of some rainy days.

As of November 19th, we have 376 Full Memberships with 14 Corporate Memberships. The marketing focus for December will continue to focus on full time, monthly and corporate memberships.

December events include weekly Ladies, Men's and Couples competitions, WGC Holiday Party December 12th, and an MGA monthly event on December 9th. We will be hosting 12+ social events during the month, many of which are holiday parties. The Knights of Columbus golf tournament will be December 2nd and we expect less than 100 people. No other major outside golf tournaments are planned for December.

December projects include- Rough pre-emergent application, rye fertilization, cut down dead trees, #9 wash clean up, bunker edging, tree pruning, add rock to #9 and #15 Conquistador tee surround.

December maintenance activities include rye fertilization, rough pre-emergent application, irrigation repairs, #9 wash clean up and tree pruning.

WATER UTILITY

CUSTOMER SERVICE

For the month of November, 225 new customers were registered for the online customer service portal. The portal now has a total of 9,345 registered users.

METER OPERATIONS

For the month of November, the Utility added 12 new service connections. The Utility now has a total of 21,375 service connections.

CIP-NORTHWEST RECHARGE, RECOVERY & DELIVERY SYSTEM (NWRRDS)

The construction continues with the Independent NWRRDS Reservoir & Booster Station. This project will allow for better distribution of our current Central Arizona Project (CAP) water into higher elevation pressure zones as well as be ready to receive additional CAP water supplies once the partnered NWRRDS project is completed.



Work on the Independent NWRRDS Reservoir and Booster station continues. Work is nearing complete on the 500,000-gallon reservoir and work has started on the 4,000 acre-ft. per year booster station. This infrastructure will further reduce the Town's dependence on groundwater as well as provide system redundancy improving system reliability.

PUBLIC OUTREACH


On November 28th, the Water Utility Director met with approximately 30 local realtors and mortgage lenders to discuss Water Resources and Community sustainability. The presentation was well received, and a lot of good questions were asked by those in attendance.

ADMINISTRATION

FINANCE

The Town continues to perform as expected in the new fiscal year given the myriad of ongoing capital projects. Total Town-wide revenues are down \$3,306,220 through September 2023 in comparison to September 2022, primarily due to \$5.4M in ARPA grant revenues recorded in July 2022. Meanwhile, total Town-wide expenditures are outpacing September 2022 by \$2,067,679, with Personnel, O&M and Capital costs all exceeding last year. OV Youth Advisory Council

OV Peak Performance

As part of OV Peak Performance, the Town's ongoing process improvement initiative, one new staff member has completed certification and earned their Lean Six Sigma Green Belt, while another new staff member has completed certification and earned their Lean Six Sigma Yellow Belt.

The Town of Oro Valley won the "Celebrating Innovation in the Workplace" (CIW) Award from the Society for Human Resource Management of Greater Tucson (SHRM-GT) in the Technology/Process Improvement category for the OV Peak Performance program. The CIW Awards recognize innovative achievements and significant improvements and accomplishments in the Human Resources field, specifically in areas of technology and process improvement, diversity and inclusion, community impact, and leadership. This is the second year in a row the Town was recognized with this award for the Peak Performance program.

Emergency Management

Town Emergency Management coordinated a test of the Town's CodeRED communication system on November 15. In combination with other communication tools, this system is used to quickly broadcast important notifications or provide emergency alerts to staff in Town facilities. More than 100 staff were successfully reached during this communications test, using various methods including text, email, and voicemail. Register for CodeRED

CodeRED is a FREE emergency notification service provided to all residents within Oro Valley that will notify you of emergency information through phone calls, text messages, emails and social media. The system will be used to keep you informed of local events that may immediately impact your safety. As a local resident, you are encouraged to take action and register your cell phone for this service and verify your home location during the enrollment process so you will receive notifications that directly impact your home or business.



INFORMATION AND TECHNOLOGY

As part of the strengthening the Town's security posture, IT has fully implemented multi-factor authentication (MFA). It is now mandatory for all Town employees to install the Microsoft Authenticator app on their mobile devices. This implementation aligns with the security prerequisites necessary to maintain our CJIS (Criminal Justice Information Systems) accreditation. In conjunction with MFA authentication, IT also required Town employees to complete the annual cybersecurity training during the month of November.
