

## **Custom Home Inspection Process Guidelines and Acknowledgement**

Single Family Custom home permits often include a Grading Permit and sometimes a Floodplain Use Permit which. Contractors are required to follow the steps outlined below for scheduling inspections on each permit type associated with Custom Home construction.

Step 1

- •The following permits are ISSUED **after** project approval and payment of fees:
- •BUILDING PERMIT for the construction of the house
- •TYPE 1 GRADING PERMIT for the site work
- •FLOODPLAIN USE PERMIT (when applicable).

Step 2

- •The Contractor msut schedule the following inspections from each permit when ready **BEFORE** the building permit inspections listed in Step 5 below:
- **GRADING PERMIT**: STORMWATER INITIAL SWPPP, ZONING LIMITS OF GRADING and PLANT SALVAGE Inspections
- FLOODPLAIN USE PERMIT: STORMWATER INITIAL FLOODPLAIN Inspection

Step 3

• Contractor prepares the Building Pad and secures a *Pad Elevation Certification* from a Surveyor

Step 4

- Contractor schedules the following inspection when ready:
- GRADING PERMIT: ENGINEERING ROUGH GRADE/PAD ELEV CERT inspection
- NOTE: After this inspection has been approved by the inspector, the GRADING PERMIT will close automatically, and no further action is required on it.

Step 5

- •Contractor to schedule the following inspections when ready:
- •BUILDING PERMIT: BUILDING PRECON AFTER GRADING PAD CERT inspection

Step 6

- Contractor to schedule all remaining inspections when appropriate/ready:
- •BUILDING PERMIT\*\*\*: All inspections listed on the permit's online portal
- •FLOODPLAIN USE PERMIT: STORMWATER FINAL FLOODPLAIN INSPECTION
