#### Membership Requirements:

1. Racquetball Courts are open Monday through Friday from 6:00 a.m.–8:00 p.m.  
Saturdays from 6:00 a.m.–5:00 p.m. and Sundays from 10:00 a.m.–5:00 p.m.  
(One court is available with extended hours. Please call in advance to reserve.)
2. Reservations are made on a first come, first served basis. Reservations may be made in person or by calling:

Mon-Fri 5:00 a.m.–8:00 p.m.; Sat 6:00 a.m.–5:00 p.m.; Sun 10:00 a.m.–5:00 p.m.

*Please be advised that the Town of Oro Valley's programs will receive priority scheduling. Courts are available for public use during non-program hours.*

3. A current Racquetball Membership form must be completed prior to making a reservation.
4. Racquetball Courts can be reserved up to two (2) hours for play.
5. All racquetball members are required to pick up and remove all personal items and litter prior to leaving the racquetball facility. ***Please note that the Town of Oro Valley is not responsible for any personal items left behind or misplaced.***
6. Court Rental Fees: A fee of \$2.00 per hour shall be charged for each hour of use. (times determined by the Parks and Recreation Department depend on season).  
Fall/Winter (Sept.–Feb.): 6:00 a.m.–9:00 a.m.; 5:00 p.m.–10:00 p.m.  
Spring/Summer (Mar.–Aug.): (No Morning Fee; / 7:00 p.m.–10:00 p.m.
7. Rental Fees: A fee of \$1.00 per Racquet along with \$.50 cents per ball will be assessed should rental be required.
8. Failure to comply with these requirements may result in loss of privileges. Charges may also be assessed for damages incurred to the racquetball courts during time of usage.
