**HOLD HARMLESS SPECIAL EVENT WAIVER FORM

**HOLD HARMLESS CLAUSE:** The Permittee, and its participants, or where the participant is a minor his/her parent/guardian shall indemnify, defend, and hold harmless the Town of Oro Valley from any and all claims, demands, suits, actions, proceedings, losses, costs, and damages of every kind and description, including attorneys’ fees and/or litigation expenses, which may be brought or made against or incurred by the Town of Oro Valley on account of loss of or damage to any property or for injuries or death of any person, caused by, arising out of, or contributes to, in whole or in part, by reasons of any act, omission, fault, mistake, or negligence of Permittee, its employees, agents, or representatives, their employees, agents, or representative in connection with or incident to the performance of this Agreement, or arising out of Worker’s Compensation claims, Unemployment Compensation claims, or Unemployment Disability Compensation claims of employees of Permittee or claims under similar such laws and obligations. Permittee and all of their participants’ obligation under the Section shall not extend to any liability caused by the sole negligence of the Town of Oro Valley or its employees.

**WAIVER:** The Permittee, all its participants, or where the Permittee is a minor, his/her parent or guardian hereby waive the right to any claim for any damages or injury of any kind accruing to the Permittee or to any participant arising out of or as a result of the use of this permit except said waiver does not extend to any such claim which is caused by the sole negligence of the Town of Oro Valley or its offices and employees.

**Students 13 years and under have to have their parent and/or legal guardian present with them during "Pull". Their parent and/or legal guardian must sign the Town of Oro Valley's – Hold Harmless Special Event Waiver Form.**

**Students 14 -17 years of age must have the Town of Oro Valley's – Hold Harmless Special Event Waiver Form signed by their parent and/or legal guardian prior to "Pull".**
